1 SCOPE:

- 1.1 This specification establishes the requirements for 1 X DIGITAL FLAT PANEL MOBILE C-ARM FLUOROSCOPIC, RADIOGRAPHIC SYSTEMS for use in the Orthopaedic, Vascular, Urology and Neurosurgery theatres at Groote Schuur Hospital.
- 1.2 The system offered must comply with or exceed all the minimum performance specifications as indicated below for the various subcomponents, supported by factory-supplied product specifications / brochures.
- 1.3 Descriptive literature, pamphlets and brochures and technical data sheets applicable to the offer (i.e., all components of system) must accompany the Bid, failing which the bid will not be considered.

1.4 The equipment and any accessories ordered from the successful Bidder will be delivered, installed, tested, calibrated, demonstrated (including specified training) and commissioned in the hospital at the expense of the successful Bidder, prior to full payment being made.

- 3.1.10 All prices are to include VAT and are to be firm prices in Rand. The Bidder is to state the period for which the firm price is valid. No rate of exchange will be negotiated in this Bid.
- 3.1.11 If the product offered is unknown to the Department, the Department reserves the right to have the unit evaluated by a team of technical and clinical experts with regards to its functionality, performance, and quality. The decision of this committee will be used as a motivation for the acceptance or non-acceptance of the unit. For this reason, a demonstration unit shall be readily available (within 5 days), or the Bidder shall take representatives of the Department to a site within South Africa where a similar unit is installed and in clinical operation. The cost for this site visit is for the account of the bidder and it will not place any obligation on the Department to procure from this specific Bidder.

4. TECHNICAL SPECIFICATIONS:

4.1 X-RAY GENERATOR AND X-RAY TUBE:

- 4.1.1 The generator shall be a high frequency converter, microprocessor-controlled X-ray generator with a nominal peak of at least 15 kW output.
- 4.1.2 The offered system shall function off a 220V (+/- 10 %) single phase 50 Hz supply and be fitted with a SABS approved 3 pin rubber plug top held down by 2 screws.
- 4.1.3 The minimum length of the power supply cord shall be 5 meters.
- 4.1.4 The maximum tube voltage shall not be less than 120kVp.
- 4.1.5 The maximum tube current shall not be less than 75mA. State max tube current.
- 4.1.6 Automatic dose control regulating both kV and mA must be included, and it should be possible to select factors manually.
- 4.1.7 The offered unit shall be a rotating anode tube system. The Bidder to state the type of tube technology employed.
- 4.1.8 The X-Ray Tube Focal Spots should be approximately 0,3mm². The Bidder to state the offered product's tube focal spots.
- 4.1.9 The Bidder to state the inherent filtration in mm Al at 75kV.
- 4.1.10 Bidder to state total beam filtration in mm Al.
- 4.1.11 State the offered unit's thermal capacity in kHU.
- 4.1.12 State the anode cooling capacity in kHU/min.
- 4.1.13 The offered unit must have the following functions/modes:

4.1.13.1 Non-stop Fluoroscopies :

- 4.1.13.1.1 kV Control between 40-120 kVp (10% tolerance) in 1 kV steps. Continuous mode
- 4.1.13.1.2 mA Control between 0.02 250 mA (10% tolerance, low dose fluoroscopy) in 0.01 mA steps.

- 4.1.13.1.3 The offered unit shall have a High-Definition Fluoroscopy mode. Indicate minimum and maximum mA.
- 4.1.13.1.4 The offered unit shall include a mode which will improve the noise levels of images for dense patients. State how this is done.
- 4.1.13.1.5 The unit shall include metal artefact reduction software.

4.1.13.2 Pulsed fluoroscopy:

- 4.1.13.2.1 kV Control between 40-120 kVp (10% tolerance) in 1 kV steps.
- 4.1.13.2.2 mA range: approximately 10 mA to 20 mA. State range and increments.
- 4.1.13.2.3 Pulsed fluoroscopic rate of approximately 0 to 15 frames per second.

4.1.13.3 Digital Radiographic Technique:

- 4.1.13.3.1 kV Control between 40 120 kVp (10% tolerance) in 1 kV steps.
- 4.1.13.3.2 The offered unit current must be at least 40mA in the DR technique. The Bidder to state mA and mAs ranges.
- 4.1.14 The offered system shall have a noise reduction filter/s. The Bidder to state the filters included in the main offer.
- 4.1.15 State what technology is employed to reduce radiation dose to patient and user.

4.2 COLLIMATOR SYSTEM:

- 4.2.1 The collimation system should include:
- 4.2.1.1 Circular opening with lead iris leaves.
- 4.2.1.2 Minimum of two independently movable lead shutters.
- 4.2.2 The shutters must be able to rotate and must be independently adjustable. The Bidder to state the degrees of rotation and the adjustability of the shutters.

- 4.2.3 The collimator system must be able to rotate 360°.
- 4.2.4 The collimators must be adjustable on live and LIH.

4.3 THE PROCESSOR AND VIEWING SYSTEM:

- 4.3.1 The image shall be electronically rotatable through 360°. This must be possible live and on LIH.
- 4.3.2 The offered product will be able to do image reversal (Black/white), annotation and measurement.
- 4.3.3 The offered product shall have an Image reversal feature for both left/right and up/down. Must be possible live and on LIH.
- 4.3.4 The monitors (minimum 19") shall make use of LCD or (better) technology and have a resolution of at least 1024 x 1024 pixels. Bidder to state the offered monitors' resolution in pixels.
- 4.3.5 The monitors must be height adjustable. The viewing angle must also be adjustable.
- 4.3.6 The offered unit shall have a timer indicating lapsed screening time on the display.
- 4.3.7 The offered system shall have a Last Image Hold (LIH) function.
- 4.3.8 The offered unit shall be able to store images for retrieval at later stage. The Bidder to specify the storage capacity. Bidders to state what media is employed.
- 4.3.9 The offered unit shall have image processing capabilities to allow for real time viewing and post processing of images.
- 4.3.10 The offered unit shall have at least a 12-bit imaging processing unit to provide maximum image quality at the lowest possible radiation.
- 4.3.11 The image display matrix shall be at least 1024 x 1280 x 8. State image matrix of offered system.
- 4.3.12 State what technology was employed to improve image quality.
- 4.3.13 It shall be possible to save the acquired images to USB.

- 4.3.14 A Windows Operating system is required, Windows 10 or later.
- 4.3.15 Specify computer Hardware.
- 4.3.16 The unit start-up time to ready to scan must be less than 3 minutes.

4.4 MOBILE STAND AND IMAGING SYSTEM:

- 4.4.1 The Mobile Stand providing support for the C-Arm and Control Cabinet must be easily maneuverable, compact, and stable. This must be 2 separate units to easily accommodate bedside imaging.
- 4.4.2 The C-Arm height adjustment of approximately 330 420 mm ($\pm 15\%$) shall be motor driven. The Bidder to state range of height adjustment.
- 4.4.3 The offered stand shall have large castors that facilitate easy movement of the complete unit. The castors shall have cable deflectors. The Bidder to state the diameter of castors.
- 4.4.4 The offered stand shall have a steering handle controlling the castors (at least 2 casters) to facilitate easy manoeuvring of the unit. It shall be possible to rotate the castors through 90 degrees to enable the unit to move in a parallel direction to the patient.
- 4.4.5 The offered stand shall have a central floor lock to lock the unit into position.
- 4.4.6 The movements of the c-arm shall be counter balanced. The Bidder to state the movements and whether they are locked by means of an electromagnetic brake or mechanical lock.
- 4.4.7 A LCD monitor must be included on the c-arm in order to improve workflow. State size of monitor.
- 4.4.8 The SID must be \pm 1000 mm. State SID of offered system.
- 4.4.9 Angulation movement estimate +90, -45 degrees.

THE NATIONAL INDUSTRIAL PARTICIPATION PROGRAMME

INTRODUCTION

The National Industrial Participation (NIP) Programme, which is applicable to all government procurement contracts that have an imported content, became effective on 1 September 1996. The NIP policy and guidelines were fully endorsed by Cabinet on 30 April 1997. In terms of the Cabinet decision, all state and parastatal purchases / lease contracts (for goods, works and services) entered into after this date, are subject to the NIP requirements. NIP is obligatory and therefore must be complied with. The Industrial Participation Secretariat (IPS) of the Department of Trade, Industry and Competition (DTIC) is charged with the responsibility of administering the programme.

1. PILLARS OF THE PROGRAMME

- 1.1 The NIP obligation is benchmarked on the imported content of the contract. Any contract having an imported content equal to or exceeding US \$10 million will have an NIP obligation. This threshold of US \$10 million can be reached as follows:
- (i) Any single contract with imported content exceeding US \$10 million;

or

(ii) Multiple contracts for the same goods, works or services each with imported content exceeding US \$3 million awarded to one seller over a 2-year period which in total exceeds US \$10 million;

or

(iii) A contract with a renewable clause, where should the option be exercised the total value of the imported content will exceed US \$10 million.

or

- (iv) Multiple suppliers of the same goods, works or services under the same contract, where the value of the imported content of each allocation is equal to or exceeds US \$3 million worth of goods, works or services to the same government institution, which in total over a two (2) year period exceeds US \$10 million.
- 1.2 The NIP obligation applicable to suppliers in respect of sub-paragraphs 1.1 (a) to 1.1 (c) above will amount to 30% of the imported content whilst suppliers in respect of paragraph 1.1 (d) shall incur 30% of the total NIP obligation on a *pro-rata* basis.

- 1.3 To satisfy the NIP obligation, the DTIC would negotiate and conclude agreements such as investments, joint ventures, sub-contracting, licensee production, export promotion, sourcing arrangements and research and development (R & D) with partners or suppliers.
- 1.4 A period of seven years has been identified as the time frame in which to discharge the obligation.

2. REQUIREMENTS OF THE DEPARTMENT OF TRADE, INDUSTRY AND COMPETITION

- 2.1 In order to ensure effective implementation of the programme, successful bidders (contractors) are required to, immediately after the award of a contract that is in excess of **R10 million** (ten million Rands), submit details of such a contract to the DTIC for reporting purposes.
- 2.2 The purpose for reporting details of contracts in excess of the amount of R10 million (ten million Rands) is to cater for multiple contracts of the same goods, works or services; renewable contracts and multiple suppliers for the same goods, works or services under the same contract as provided for in paragraphs 1.1. (b) to 1.1. (d) above.
- 2.3 For bids above R10 million, accounting officer's authorities are required to obtain clearance from the Department of Trade and Industry regarding the National Industrial participation Programme prior to the award of any bid in excess of R10 million (ten million rands).
- 3. BID SUBMISSION AND CONTRACT REPORTING REQUIREMENTS OF BIDDERS AND SUCCESSFUL BIDDERS (CONTRACTORS)
- 3.1 Bidders are required to sign and submit this Standard Bidding Document (SBD5) together with the bid on the closing date and time.
- 3.2 In order to accommodate multiple contracts for the same goods, works or services; renewable contracts and multiple suppliers for the same goods, works or services under the same contracts as indicated in sub-paragraphs 1.1 (b) to 1.1 (d) above and to enable the DTIC in determining the NIP obligation, successful bidders (contractors) are required, immediately after being officially notified about any successful bid with a value in excess of R10 million (ten million Rands), to contact and furnish the DTIC with the following information:
- Bid / contract number
- Description of the goods, works or services.
- Date on which the contract was accepted.
- Name, address and contact details of the government institution.
- Value of the contract.
- Imported content.
- Imported content of the contract, if possible

4. PROCESS TO SATISFY THE NIP OBLIGATION

- 4.1 Once the successful bidder (contractor) has made contact with and furnished the DTIC with the information required, the following steps will be followed:
- (a) The contractor and the DTIC will determine the NIP obligation;
- (b) The contractor and the DTIC will sign the NIP obligation agreement;
- (c) The contractor will submit a performance guarantee to the DTIC;
- (d) The contractor will submit a business concept for consideration and approval by the DTIC;
- (e) Upon approval of the business concept by the DTIC, the contractor will submit detailed business plans outlining the business concepts;
- (f) The contractor will implement the business plans; and
- (g) The contractor will submit bi-annual progress reports on approved plans to the DTIC.
- 4.2 The NIP obligation agreement is between the DTIC and the successful bidder (contractor) and, therefore, does not involve the purchasing institution.

- 1.7 "Code of Good Practice" means the generic codes or the sector codes as the case may be;
- 1.8 "consortium or joint venture" means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract
- 1.9 "contract" means the agreement that results from the acceptance of a bid by an organ of state;
- 1.10 "EME" is an Exempted Micro Enterprise with an annual total revenue of R10 million or less.
- 1.11 "Firm price" means the price that is only subject to adjustments in accordance with the actual increase or decrease resulting from the change, imposition, or abolition of customs or excise duty and any other duty, levy, or tax, which, in terms of the law or regulation, is binding on the contractor and demonstrably has an influence on the price of any supplies, or the rendering costs of any service, for the execution of the contract;

- 1.12 "Large Enterprise" is any enterprise with an annual total revenue above R50 million;
- 1.13 "non-firm prices" means all prices other than "firm" prices;
- 1.14 "person" includes a juristic person;
- 1.15 "price" means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- 1.16 "proof of B-BBEE status level contributor" means-
 - (a) The B-BBEE status level certificate issued by an authorized body or person;
 - (b) An affidavit as prescribed in terms of the B-BBEE Codes of Good Practice; or
 - (c) Any other requirement prescribed in terms of the Broad-Based Black Economic Empowerment Act.
- 1.17 **QSE** is a Qualifying Small Enterprise with an annual total revenue between R10 million and R50 million;
- 1.18 "rand value" means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- 1.19 "sub-contract" means the primary contractor's assigning, leasing, making out work to, or employing, another person to support such primary contractor in the execution of part of a project in terms of the contract.
- 1.20 "tender" means a written offer in the form determined by an organ of state in response to an invitation to provide or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- 1.21 "tender for income-generating contracts" means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions;
- 1.22 "the Act" means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000);
- 1.23 "the Regulations" means the Preferential Procurement Regulations, 2022;
- 1.24 "total revenue" bears the same meaning assigned to this expression in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act and promulgated in the *Government Gazette on 11 October 2013*;
- 1.25 "trust" means the arrangement through which the property of one person is made over or bequeathed to a trustee to administer such property for the benefit of another person; and

- 3.1 Subject to Section 2 (1) (f) of the Preferential Procurement Policy Framework Act, 2000, the bidder obtaining the highest number of total points will be awarded the contract.
- 3.2 A tenderer must submit proof of its B-BBEE status level of contributor in order to claim points for B-BBEE.
- 3.3 A tenderer failing to submit proof of B-BBEE status level of contributor or is a non-compliant contributor to B-BBEE will not be disqualified but will only score:
 - (a) points out of 80 for price; and
 - (b) 0 points out of 20 for B-BBEE

- 3.4 Points scored must be rounded off to the nearest 2 decimal places.
- 3.5 In the event that two or more bids have scored equal total points, the successful bid must be the one scoring the highest number of preference points for B-BBEE.

	1.6	"Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.			
	1.7	"Day" means calendar day.			
	1.8	"Delivery" means delivery in compliance of the conditions of the contract or order.
