1. PURPOSE

The National Arts Council (NAC) is embarking on an executive recruitment search assignment for the role of the Chief Executive Officer.

The purpose of this Request for Quotation (RFQ) is to seek responses from Executive Search Recruitment Service Providers for the recruitment of the NAC Chief Executive Officer.

The National Arts Council seeks to appoint services of a suitably qualified service provider to recruit/headhunt for a Chief Executive Officer, to be responsible for the execution and implementation of the strategy of the organisation as delegated by Council.

2. BACKGROUND

The National Arts Council (NAC) is a Schedule 3A Public Entity in terms of the Public Finance Management Act (PFMA). The NAC is governed by the National Arts Council Act 56 of 1997 as amended by the Cultural Laws Amendment Act 36 of 2001, and is an agency of the Department of Arts and Culture

The mandate of the NAC, as set out in Section 3 of the NAC Act is:

- To provide, and encourage the provision of, opportunities for persons to practice the arts
- To promote the appreciation, understanding and enjoyment of the arts
- To promote the general application of the arts in the community
- To foster the expression of a national identity and consciousness by means of the arts
- To uphold and promote the right of any person to freedom in the practice of the arts
- To give the historically disadvantaged such additional help and resources as are required to give them greater access to the arts
- To address historical imbalances in providing infrastructure for the promotion of the arts
- To promote and facilitate national and international liaison between individuals and institutions in respect of the arts;
- To develop and promote the arts and to encourage excellence in regard to these

The Accounting Authority of the NAC is the Council which is established in terms of Section 4 of the NAC Act.

3. SCOPE OF THE SERVICE PROVIDER

1. Advise on the final Job Profile and final Advert to go to market;
2. Develop and advise on the mechanism for the recruitment of the Executive position;
3. Begin the recruitment process from the labour market using both advertisement and headhunting;
4. Screening of candidates ;
5. Shortlisting of candidates for presentation to the NAC ;
6. Conducting Psychometric Testing and backgrounds checks on shortlisted candidates;
7. Presenting of results of the Psychometric Tests to NAC;
8. Response handling and all associated correspondence with all candidates throughout the selection process.
9. Facilitate the selection process up to offer stage and on-boarding of the successful candidate;

4. EVALUATION CRITERIA

Proposals will be evaluated in the following three Phases:

- **Phase 1:** Compliance with administrative requirements
- **Phase 2:** Technical/Functional evaluation of proposals
- **Phase 3:** Price and BBBEE scoring in terms of PPPFA.

4.1 Phase 1: Minimum and Administrative Requirements

The bidder will proceed to the next stage when they comply with the following requirements:

- SARS Tax Pin Number/Valid Tax Clearance certificate;
- BBBEE status level certificate –Accredited by SANAS BEE verification agency. Failure to submit a BEE certificate or a valid BEE Certificate does not mean disqualification from further evaluation but will influence the score for BEE Points as prescribed in the Preferential Procurement Regulations;
- EME'/QSE's with an annual total revenue of R10 million or less are required to obtain a sworn affidavit or certificate issued by companies Intellectual Property Commission (CIPC);
- Signed SBD1 document;
- Signed declaration of interest document;
- Completed and signed Company Information document and submission of all the required documentation as stipulated in the Mandatory Requirements Section below;
- Technical and administrative requirements should be clearly separated with heading Administrative and/or Technical.
- The CSD (Central Supplier Database) is a single source of all supplier information for all spheres of government and all suppliers engaging with the PIC should be registered on the CSD.

4.2 Phase 2: Technical / Functional Criteria

With regard to technicality/functionality, the following criteria shall be applicable and the maximum weight of each criterion is indicated in the table below:

Points awarded for B-BBEE Status Level of Contribution

Broad-Based Black Economic Empowerment Status Level Certificates

Bidders with annual total revenue of R10 million or less qualify as Exempted Micro Enterprises (EMEs) in terms of the Broad-Based Black Economic Empowerment Act, and must submit a certificate issued by a registered auditor, accounting officer (as contemplated in Section (60 (4) of the Close Corporation Act, 1984 or an accredited verification agency.

Bidders other than the Exempted Micro-Enterprises (EMEs) must submit their original and valid BBBEE status level verification certificate or a certified copy thereof issued by a SANAS accredited agency, substantiating their BBBEE rating.

Points will also be awarded based on a bidder for attaining their B-BBEE status level of contribution in accordance with the table below

In terms of Regulation 5 (2) and 6 (2) of the Preferential Procurement Regulations, preference points must be awarded to a bidder for attaining the B-BBEE status level of contribution in accordance with the table below.

4.4 Points scored will be rounded off to the nearest two decimal places. The Bidder who scored the highest point will be awarded the bid.

4.5. In the event where two or more bidders scored equal points, the successful bidder must be the one scoring the highest preference points for BBEE.

4.6 However, when functionality is part of the evaluation process and two or more bidders have scored equal points including equal preference points for BBEE, the successful bidder must be the one scoring the highest for functionality.

4.7 Should two or more bidders be equal in all respects, the award shall be decided by the drawing of lots.

5. CONDITIONS

5.1 Non-Commitment

5.1.1 The cost of preparing of bids will not be reimbursed.

5.1.2 The NAC reserves the right to withdraw or amend these terms of reference by notice in writing to all parties who have received the terms of reference prior to the closing date.

5.2 Reasons for Rejection

The NAC reserves the right to reject bids that are not according to specification/Terms of Reference. Bidders must clearly indicate compliance or non-compliance with specification/Terms of Reference.

5.2.1 Bidders shall not contact the NAC on any matter pertaining to their bid from the time the bids are closed to the time the bid has been adjudicated. Any effort by a bidder to influence the bid evaluation, bid comparisons or bid award decisions in any matter, may result in rejection of the bid concerned.

5.2.2 The NAC shall reject a submission if the Bidder has committed a proven corrupt or fraudulent act in competing for a particular contract.

5.2.3 The NAC may disregard any submission if that Bidder, or any of its directors

5.2.3.1 Have abused the Supply Chain Management (SCM) system of any Government Department/ institution;

5.2.3.2 Have committed proven fraud or any other improper conduct in relation to such system;

5.2.3.3 Have failed to perform on any previous contract and the proof thereof exists; and/or

5.2.3.4 Is restricted from doing business with the public sector if such a bidder obtained preferences fraudulently or if such bidder failed to perform on a contract based on the specific goals.

5.3 Cancellation of Bid

5.3.1 The NAC may prior to the award of a bid, cancel a bid for the following reasons

5.3.2 Due to changed circumstances, there is no longer a need for the goods or services requested:

5.3.3 Funds are no longer available to cover the total envisaged expenditure;

5.3.4 No acceptable bids are received.

5.4 The NAC may after award of the tender but before conclusion of a contract, cancel a bid for the following reasons-

5.4.1 Due to change of circumstances, there is no longer a need for the goods or services requested;

5.4.2 Funds are no longer available to cover the total envisaged expenditure.

5.5 PRESENTATIONS

5.5.1 The NAC will require presentations at a stipulated date and time from short-listed bidders as part of the bid process.

5.6 SERVICE LEVEL AGREEMENT (SLA)

5.6.1 The SLA will set out the administration processes, service levels and timelines.

5.6.2 The award of a tender shall always be subject to successful negotiation and conclusion of an SLA / contract. There will be no binding agreement between the parties if a contract has not been concluded.

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
