The Established Contractor shall be registered in CIDB contractor grading designation **5GB or higher**.

A compulsory briefing session and site visit will be held on **Friday, 29 July 2022 at 10H00, at uMzinyathi District Municipality Offices**. Failure to attend the compulsory briefing meeting will result in the tenderer's bid being rejected or disqualified. Tenderers wishing to attend the clarification meeting are to strictly adhere to the following procedures:

Locally produced or manufactured goods, meeting the stipulated minimum thresholds for local production and content for all Designated Sectors in the Declaration Certificate (MBD6.2) will be considered.

Tenderer(s) will be required to subcontract a minimum of 10% of the value of contract to the Targeted Enterprise.

Only bidders who score **70 points** on functionality criteria will qualify for the second stage of evaluation.
