  - 2.4. If the bidder fails to make full payment within 90 days (3 months) amount paid to the municipality will be forfeited.

### MINIMUM REQUIREMENTS

1. A valid South African Identity Document (certified copy not older than 3 months before closing date).
2. In case of company attach Company registration certificate and certified copies of Director's ID
3. Completed and signed application form.
4. Any bid below market-value will be disqualified.

## **FUNCTIONALITY EVALUATION**

1. The bid will be awarded to the highest qualifying bidder.
2. There is no Minimum score or percentage to meet functionality requirements

### **80/20 preference points system for tenders for income-generating contracts with Rand value equal to or below R50 million**

1. The following formula must be used to calculate the points for price in respect of an invitation for tender for income-generating contracts, with a Rand value equal to or below R50 million,

$$Ps = 80 \left( 1 + \frac{Pt - Pmax}{Pmax} \right)$$

Where-

Ps = Points scored for price of tender under consideration;

Pt = Price of tender under consideration; and

Pmax = Price of highest acceptable tender.

2. A maximum of 20 points may be awarded to a tenderer for the specific goal specified for the tender. (The allocation of preference points for tenders above the quotation threshold to be decided and allocated per tender)
3. The points scored for the specific goal must be added to the points scored for price and the total must be rounded off to the nearest two decimal places.
4. Subject to section 2(1)(f) of the Act, the contract must be awarded to the tenderer scoring the highest points.
