Introduction to the NRF

All proposals will be evaluated by Supply Chain Management for administrative compliance, functionality, price and B-BBEE. Based on the results of the evaluation process and upon successful negotiations, iThemba LABS will approve the awarding of the contract to the successful bidder.

- **Preference points system:**

The 80/20 preference point system will be used where 80 points will be dedicated to price and 20 points to B-BBEE status. "If all bids received are more than R 1 000 000.00, this request is automatically cancelled".

Subject to section 2(1)(f) of the PPPFA, the contract will be awarded to the tenderer scoring the highest points.

No price quotations or competitive bids shall be awarded to business or persons who are not tax compliant.

VERTICAL BLINDS -Supply & Install 127mm wide vertical Block out light grey blind with right hand side control.

Head Rail is powder coated white aluminium 45 mm wide x 22 mm high.

- All plastic components are made of Acetyl plastic with UV protective additive.
- All runners are to have a clutch that allows vanes to be re-arranged.
- Heavy bottom weights with nylon cord connectors are installed to connect the vanes.
- All plastic components are UV protected
- All cords are dimensionally stable and operating chains are stainless steel or ball-chain plastic as required.
- Only fully Internationally compliant and locally tested fabrics are to be used as vanes.

Sample swatches will be required for the final selections of colours and fabric from the successful bidder.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
