

## **TENDER BID: TO INSTALL A 3.4km HDPE PIPELINE AT ALEXKOR MINE – MUISVLAK PLANT, 10 KM NORTH OF PORT NOLLOTH**

**TENDER NUMBER: ALEX RFP 04/2024**

Alexkor RMC JV is inviting the interested companies to submit their proposal to supply and install a 3.4km High Density Polyethylene (HDPE) Pipeline.

### **1. THE SCOPE OF WORK INCLUDES:**

- a) Supply and Install a 3.4km long, 250mm x 14m HDPE SDR11 PN16 pipes line.
- b) Join the installed pipeline to the existing pipeline.
- c) Supply the relevant stubs, flanges, bolts and nuts.
- d) Join the PVC pipes using High Frequency or RF welding.
- e) Join the PVC stubs using High Frequency or RF welding.
- f) Supply and install 7 x 80mm cast iron flanged air release valves.
- g) Any other item(s) identified during site inspection.

### **2. THE CONDITIONS:**

Please note the following:

- a) Interested and capable companies to forward proposals to supply and install the sea water pipe line.
- b) As part of the proposal, interested parties have to prove that they have adequate knowledge and experience required to undertake the project for the scope of work listed in no. 1 above. As well demonstrate the availability of the financial resources to complete the work listed in no.1 above;
- c) The interested parties also need to indicate that they have the ability to mobilize to the site within a reasonable period of time
- d) Companies are requested to include, as part of their proposal, a plan on how they intend on:
  - o Supplying and installing the above mentioned pipe line.
  - o Welding and joining the pipes and stubs
  - o Connecting the new pipeline to the existing pipeline
  - o Any other work required during the installation
- e) The expression must provide all-inclusive costs that will ensure that this job is completed
- f) Compliance to the Mine Health and safety Act and Occupational Health and Safety is a requirement.
- g) A service level agreement shall be entered into, with Alexkor RMC JV.
- h) The successful contractor shall indicate how long it will take to start work after receiving an award letter.
- i) Preference will be given to a Contractor who meet:
  - o All the conditions in 2. a) to g) above;
  - o Have submitted all the documents listed in 4. below; and

- Have achieved the highest score in the evaluation.
- j) **The compulsory site briefing/inspection will take place on Monday, 22 May 2023 at 10:00 at the Alexkor RMC JV -Muisvlak Plant, 10 km north of Port Nolloth.** Please note that all attendees need to wear protective clothing (Reflector vest), hard hat and safety boots.
