Specific Goal for EDUMT14/2026/27: In the 80/20 Points System, **Local economic development**, 20 points allocated to Enterprises within eDumbe Local Municipality boundaries, 15 points allocated to Enterprise within KwaZulu-Natal (KZN) boundaries, 10 points allocated to Enterprise within broader South African boundaries, providing valid proof (rates account within 3 months, valid lease agreement, or proof of address **ONLY** where businesses are rural based), while missing or invalid proof scores 0 points.
