1. INTRODUCTION TO THE NRF

The NRF provides these services in all fields of science and technology, including natural science, engineering, social science, and humanities.

1.1. INTRODUCTION TO THE BUSINESS UNIT (SAAO) RESPONSIBLE FOR THIS RFQ

The South African Astronomical Observatory (SAAO) is a facility of the National Research Foundation and is the national centre for optical and infrared astronomy in South Africa. Its prime function is to conduct fundamental research in astronomy and astrophysics by providing a world-class facility and by promoting astronomy and astrophysics in Southern Africa.

2. SUPPLY SPECIFICATIONS

SAAO invites the submission of quotations for the following:

SAAO seeking to appoint an accredited service provider to provide all-in-one sanitary waste collection and disposal service.

Contract period is 36 months

Accredited service provider to provide all-in-one sanitary waste collection and disposal service. SAAO reserves the right to add or remove services or change the quantity as business needs change.

Site location: SAAO, 2 Observatory Road, Observatory, Cape Town.

The following is required:

- Supply (on a rental basis) and maintenance of the sanitary hygiene bin;
- Supply and refill of sanitary hygiene consumables;
- Only SABS approved cleaning products to be used;
- Service provider to price per SHE bin;
- SHE bins to be emptied once per week;
- Deploy sufficient staff on the contract to ensure completion of the works within programme and within normal working hours - Weekdays 8 to 5pm;
- Ensure timely and efficient execution of the Works with minimum interruption to the SAAO;
- Ensure adherence to the OHSA Act, and
- Ensure that any staff member/technician working at the SAAO are issued with safety clothing with the company's name clearly visible.

Removal of Sanitary Bins (All Ladies and Unisex ablution facilities)

Must contain a 50 micron "sanibin" polythene liner, Service intervals are based on a seven (7) day cycle.

All liner bags must be changed weekly with a set colour range indicating that the liners were serviced and changed.

Treatment of sanitary bins to be done by the service provider.

A certification of safe disposal will be required after disposal (waste manifest).

The bins must be sealed units, secured, and only the service provider must have access to the units when completing a service.

The service provider shall supply, install and maintain the equipment listed below on a rental basis.

- All equipment will be installed by the service provider. All installations and removals of the equipment will be subject of consent from SAAO;
- The Service Provider must ensure all the hygiene equipment is supplied and installed within a month of award of contract;
- SAAO expects a 48 hours' service from receipt of the purchase order. If the successful bidder does not comply within the 48 hours' service period, SAAO reserves the right to at its discretion, make use of a third party and hold the successful Bidder responsible for payment to the third party serviced delivered;
- All items/models delivered in terms of this contract shall be new and unused with the appropriate guarantees for the duration of the contract; and
- The service provider must ensure that defective equipment is either replaced or repaired within 24 hours from the time such equipment is reported by SAAO facility's representative.

Sanitary hygiene bin (SHE Bin)

- 20 Litre white Plastic Pedal Operated Slimline Sanitary Bin;
- Pedal sanitary bin made from robust ABS plastic providing durability;
- Heavy duty pedal for hands free sanitary disposal;
- Must have self-closing, tight fitting lid with trap doors;
- Bins will be replaced free of charge in the event of breakage though normal wear and tear;
- Sanitary bins must be lined with appropriate bin liners;

- The bin liners to be replaced with every service;
- Chemical inactivate all bacterial and viral growth due to the hazards of medical and other types of waste; and
- The chemical should release a bacterial vapour with a pleasant fragrance.

 - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
 - (e) forward the matter for criminal prosecution, if deemed necessary.
