## 1. BACKGROUND

The two-spotted stink bug, *Bathycoelia distincta* (Distant) (Hemiptera: Pentatomidae), is the most abundant stink bug species in macadamia orchards in South Africa. This pest is associated with severe macadamia nut damage and is mainly controlled with insecticides, placing selection pressure on the pest, which can result in resistance development. Chemical control also poses potential health and environmental risks, and alternative pest management tactics are therefore required. The use of effective entomopathogenic fungi (EPFs), which are naturally occurring and environmentally friendly biological control agents with insecticidal action, may reduce these negative effects. The potential of *Beauveria bassiana* for control of *B. distincta* was demonstrated in a small-scale study and further research in this regard is justified.

To proceed to large scale field trials of *B. bassiana*, a commercial formulated product is needed. The large-scale mass rearing of the fungus and formulation into a product is necessary to conduct large-scale trials and to register a product on macadamia for the control of the two spotted stinkbug. An investment in a formulated product, which will be commercialised if found as effective as in the semi field trials, is requested in this tender.

## 2. PURPOSE

The ARC requires the services of a service provider to assist in the development of a formulated product from a fungal *Beauveria bassiana* isolate for use in large scale field trials, and if successful, further commercialization of the product for to use in the control of the two spotted stinkbug on macadamia. The scope of work should be defined through the **Expression of Interest** and the service providers will be requested to present their scope of work to the Bid Evaluation Committee by providing 1) a document with compulsory bid requirements and 2) giving an oral presentation of the scope of work; including timelines for the formulation of the product, large scale testing in different climatic conditions over two seasons and the timeline for registration of the product.

### **3. MOTIVATION/S FOR CONSIDERATION**

*Beauveria bassiana* isolate PPRI 26695 was assessed in the laboratory and in semi field trails for its efficacy in the control of the two-spotted stink bug, *Bathycorixa distincta* (Distant) (Hemiptera: Pentatomidae). To proceed to large scale field trials, a commercial formulated product is needed for further tests.

Chemical control also poses potential health and environmental risks, and alternative pest management tactics are therefore required. The use of effective entomopathogenic fungi (EPFs), which are naturally occurring and environmentally friendly biological control agents with insecticidal action, may reduce these negative effects.

### **4. SCOPE OF EXPRESSION OF INTEREST**

- Provide a timeline with milestones for the mass production and formulation of a product, including registration and commercialization.
- Product registration will be the responsibility of the service provider on behalf of the ARC, including all processes needed for commercialization of the product.
- Explain how this will be achieved. Include a timeline to conduct product trials in different climatic conditions Macadamia production regions- KZN, Limpopo and Mpumalanga as prescribed by the Act 36 The Fertilizers, Farm Feeds, Seed and Remedies Act 36 of 1947 for the control of the two-spotted stinkbug.
- Provide the characteristics of the proposed end product, i.e. wettable powder product or as an emulsifiable concentrate, lowest effective concentration, ease in field application, longevity of the product to control all life stages of the stinkbug and shelf life.
- Service provider must provide an estimated project value.

### **5. EXPRESSION OF INTEREST SUBMISSION**

## **5.1 Administrative Requirements**

- A valid Tax PIN Number from SARS.
- Current Central Supplier Database (CSD Report).
- Company registration documents from CIPC.
- The respondent must complete and sign all Standard bidding documents

## **5.2 Mandatory Requirements**

- Oral presentation to demonstrate the company experience and capability as per the scope of work, indicating milestones and timelines for the project and company background. This should include the complete registration and commercialisation process timelines.
- Accreditation status/registration with relevant professional bodies.
- Years of experience in delivering a formulated product to industries for the use in biological control strategies. A detailed product list should be included in the document.
  - List the company's experience to mass rear Beauveria and indicate an example of a commercial product that is currently on the market.
  - Describe how the company took the fungal isolate from product to commercialization
- Supply a company profile with qualifications and experience of members of the team.
  - Demonstrate the capacity to upscale the production of a product and competitive pricing of existing products.
  - List the climatic zones where trials for the formulated product will be tested, propose to include dryer and wetter regions to compare efficacy under different climatic conditions.
  - List the potential risks of the project and mitigation steps
- Company registration documents from CIPC.

## **6. CONFIDENTIALITY**

The appointed service provider will be required to sign a confidentiality agreement and ensure all information obtained during the assessment remains confidential.

## **7. VETTING CRITERIA**

- A complete vetting process will be followed.
- The proposed supplier will be vetted according to the following criteria:

**Submission of administrative and mandatory requirements listed above and general Information of the supplier as requested below.**

**Indicate any special requirements related to the successful execution of this project.**

## **8. GENERAL INFORMATION**

- Companies must be prepared to enter a valid 'Evaluation agreement' and/or 'License Agreement' with the ARC.
- Submit a preliminary proposal on how the company will assist the ARC with the commercialization of the ARC research products.
- The ARC must have full access to products during all stages of multiplication, evaluation and commercialization.
- The interested company must have a proven track record of scope of work related to this project.
- For international evaluation and commercialization, the company must provide a proven record and footprint of international activities.
- The Company must indicate how ARC products in their possession will be protected.
- The Company must have security controls in place to restrict access of individuals to the product under evaluation.
- Should the Company contravene any of the stipulations, the ARC has the right to terminate the partnership.

## **9. SCOPE OF EXPRESSION OF INTEREST**

- The proposal from interested parties should be concise as possible.
- Service providers must complete the attached EOI form relating to the commercialisation process.
- All supporting documents should be attached as appendices.

- The company profile, including possible evaluation sites.
- Details of the current activities.
- Evidence of experience as requested above.
- Information on technical capabilities and available resources as detailed above to enable successful multiplication evaluation and commercialization of product(s).

## **10. COSTS OF SUBMISSION**

Parties submitting an Expression of Interest assume all risks for resource commitment and expenses, direct or indirect, of proposal preparation and participation throughout the EOI process. The ARC is not responsible directly or indirectly for any costs incurred by the parties.

## **11. SITE VISITS**

The ARC may decide/request to visit the shortlisted companies to further conduct suitability assessments. Arrangements for the visits will be coordinated well in advance.

## **12. PROCESS FOR SHORTLISTED APPLICANT/S**

The shortlisted applicant/s will proceed to the application phase where further assessments will be completed.

The successful applicant will be subject to the parties agreeing to mutually acceptable terms and conditions. In the event of the parties failing to reach such

agreement within a mutually agreed date after the provisional appointment date, the ARC reserves the right to appoint or not appoint.
