**REQUEST FOR QUOTATION**

**Iziko Museums of South Africa (Iziko) invites service providers to submit proposals for grass cladding and exhibition maintenance and fire door installation at Iziko South African Museum.**

## **BACKGROUND IZIKO**

Iziko Museums of South Africa (Iziko) is a schedule 3A public entity and non-profit organisation, partly subsidised by the National Department of Sport, Arts & Culture (DSAC), bringing together 11 national museums and a Social History Centre situated in the Western Cape under a single governance and leadership structure. Iziko was established in terms of the Cultural Institutions Act, 1998 (Act No. 119 of 1998) and is required to comply with the Public Finance Management Act (PFMA), 1999 (Act No. 1 of 1999, as amended) and its concomitant Regulations.

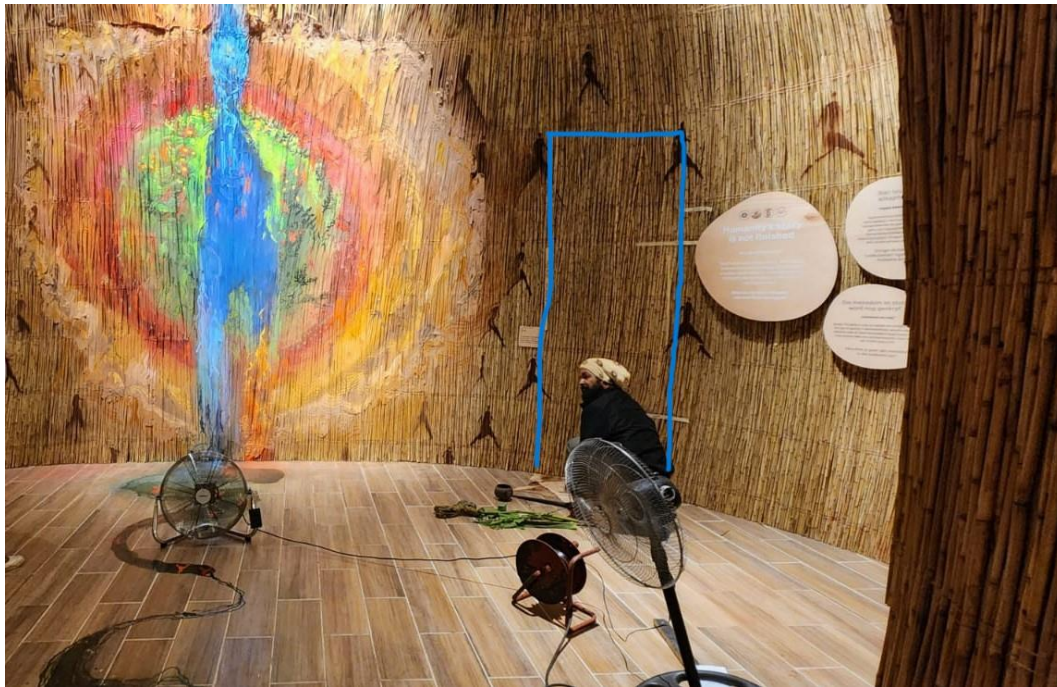
The Iziko South African Museum has installed a large grass reed cladding structure across three large rooms for an exhibition. This structure needs periodic maintenance. The structure is hand-built from grass reeds and rests on a steel frame structure. The structure has access points that need to be navigated carefully to ensure the safety of the objects and content that have been installed on it and against it (see Room 1 image of the installation below).



### **1. Scope of Services/Goods**

- a) Installation of a fire access or exit doorway in the fixed grass reed cladding structure. The grass will need to be cut and the steel frame amended to facilitate the potential opening and closing of an emergency doorway. The doorway must be able to be opened easily and must be aesthetically appealing, matching the look and feel of the existing exhibition (location of door marked in blue on grass cladding below). Fire door installation **deadline of 15 March 2024**.

c) Installation of strip lighting covers (circled in blue in image below). There currently exists a series of two LED strip light sections across the stone tool section of the exhibition. Requirements:

- Development and installation of additional (approx..5m) custom made, aluminium cover that will help defray light.
- The entire strip lighting structure (approx. 12m x 10cm) needs to be clad in reeds to match the look and feel of the existing exhibit.
- Installation **deadline of 30 March 2024.**

## 2. EVALUATION CRITERIA

Iziko promotes the concept of “best value” in the award of contracts, as opposed to merely looking for the cheapest price, which does not necessarily provide the best value. Best value incorporates the expertise, experience and technical proposal of the organisation and individuals who will be providing the service and the organisational capacity supporting the project team.

Iziko is committed to achieving Government’s transformation objectives in terms of the Preferential Procurement Policy Framework Act.

- Scoring assessment based on experience and meeting deadlines will be done in terms of the scoring criteria in Table 3 and the minimum threshold of **80** points. A bid will be disqualified if it fails to meet the minimum threshold for scoring as per the bid invitation.
- Proposals will be evaluated on the 80/20 preference points scoring system: that is, 80% of the points awarded will be based on price, as indicated in the table below; and 20% of the points awarded will be based on specific goals, allocated as indicated in the table below:

**Scoring Criteria:**

Service providers must meet minimum experience and timeline requirements to participate in the bid. Respondents must score **80 points** from the scoring criteria outlined in Table 3 to be considered for this project. Any bids not achieving 80 points will be disqualified from participating. Scores will be tabulated to 100 points.

**Experience:** The experience of the service provider in projects of similar nature and conditions in relation to the scope of work over the last three (3) years will be evaluated. Bidders should briefly describe his or her experience in this regard and attach this to this schedule.

**Stock availability:** The service provider must demonstrate stock of or access to the same grass reeds (*amacansi*) as those used in the current build so that replacements and additions to the build can be made.

**Meeting timelines:** The service provider must stipulate that they can meet our fire door installation deadline of 15 February 2024, as well as be available over the two-year period for maintenance purposes. Project duration is estimated from 15 January 2024 – 14 January 2026.

**1. GENERAL CONDITIONS**

1.1 The following preference point systems are applicable to invitations to tender:

- the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
- the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

1.2 **To be completed by the organ of state**

The applicable preference point system for this tender is the 80/20 preference point system.

1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

- (a) Price; and
- (b) Specific Goals.

1.4 **To be completed by the organ of state:**

The maximum points for this tender are allocated as follows:

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

## 2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

## 4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
