All suppliers applying for this tender must register on the Municipal database

Tenders will be opened to public. Tenders received after the due date and time will not be considered.

It is the tenderer's responsibility to provide all the data and information requested in the form required, failure to do so may be regarded by the employer as a non-responsive tender.
