## Background

Eskom Atmospheric pollution from industrial sources, including the Eskom power generating industry, continues to be a major concern in South Africa. In particular, it is of paramount importance to understand the contributions of the myriad of pollution sources to observed concentrations if regional planning is to be conducted in a scientific manner. Ambient monitoring and modelling provide the means to accomplish these objectives on a non-partisan basis and over a wide range of parameters that need to be monitored to get a holistic picture. The continued monitoring and modelling ensures data that can provide key information for future strategic planning.

RT&D is providing the service of ambient air quality monitoring in order to meet Eskom's atmospheric emissions licence compliance requirements. The air quality monitoring network (which is accredited to SANAS 17025 requirements) comprises on 21 monitoring stations. In order to maintain a comprehensive service it is critical that these stations are fully resourced with the necessary monitoring equipment and instrumentation in order to maintain the required level of data capture and accreditation requirements.
