1. PURPOSE

The purpose of this exercise is to appoint a legible service provider for the once-off supply and delivery of foul weather gear to the Storms River Mouth Rest Camp, Tsitsikamma section of the Garden Route National Park.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under *National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003)*; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the *Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999)*, and it is listed as *Schedule 3 Part A: 25 public entities*. SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

5. SPECIAL CONDITIONS:

- a) Suppliers will be required to submit pictures of the sample or consignment at the tender submission stage.
- b) Supplier to be able to deliver the boots within fourteen (14) days after a purchase order has been issued.
- c) Supplier will be required to deliver the foul weather gear and costs to be included in the quotation.

6. DELIVERY PERIODS:

- a) Lead time for delivery of goods must not exceed fourteen (14) days after the placement of an official purchase order.
- b) Failure to comply, will lead to the automatic cancellation of the order, unless agreed otherwise with the park.
- c) The park may due to non-compliance to a delivery period, proceed to obtain the required goods in which ever manner which is to its best advantage. A written notice of cancellation of order will be issued only.

7. SUBMISSION OF SAMPLES:

- a) The shortlisted tenderer will be required to submit samples for each item they submit upon issuing of a purchase order. Failure to comply, will result in the tenderer offer not been considered.
- b) Samples must be submitted within fourteen (14) days upon receiving the request to submit samples. Failure to comply, will result in the tenderer offer not been considered.
- c) Samples should be clearly marked with the tenderer's name and the tender number included.
- d) Samples will be at the tenderers' expense and the expenses are not refundable.
- e) Samples must be provided at the tenderers own cost, for the item/s they are responding to before the issuing of the purchase order.

- g) The Tsitsikamma National Park reserves a right to have a sample tested at any given time.
- h) Where a contract is awarded on the grounds of evaluation of a representative sample, such sample is kept for the contract period and is regarded as the contract sample.

Deliveries are then compared with it in order to ensure that the quality does not deteriorate. However, if it does not correspond exactly with the contract sample, the consignment will be rejected and the contractor requested to remove and replace it immediately.

 - (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
 - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,
 then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.
