## TERMS OF REFERENCE

### **Procurement of Multi-Factor Authentication (MFA) Licenses for Employee Self-Service (ESS) (payday v9.0 or latest version payroll portal)**

---

#### **1. Background**

The Municipality is in the process of implementing the Employee Self-Service (ESS) system, which will allow employees to access and manage personal and payroll-related information online.

Given the sensitivity of the information handled within ESS, it is critical to enhance system security through the implementation of Multi-Factor Authentication (MFA) for the pay day v9.0 or latest version ESS payroll portal for EMLM. MFA will provide an additional layer of security beyond usernames and passwords, thereby reducing the risk of unauthorized access and data breaches.

#### **2. Objective**

The objective of this procurement is to appoint a qualified service provider for the supply, configuration, and support of **250 Multi-Factor Authentication (MFA) licenses** for a period of **12 months** to secure access to the ESS system.

---

#### **3. Scope of Work**

The appointed service provider will be required to:

##### **3.1 Supply of Licenses**

- Provide **250 MFA licenses** valid for a period of 12 months
- Licenses must be scalable to accommodate future growth

##### **3.2 Implementation and Configuration**

- Configure MFA for integration with the ESS system PayDay v9.0 or latest ESS portal
- Ensure compatibility with existing ICT infrastructure
- Enable secure authentication methods (e.g., mobile app, OTP, push notifications, biometrics where applicable)

##### **3.3 Security Features**

The MFA solution must include:

- Multi-factor authentication (at least two factors: something you know, have, or are)
- Support for mobile-based authentication (Android and iOS)
- OTP (One-Time Password) functionality

- Push notification authentication
- Conditional access policies (e.g., location/IP-based access)
- Encryption of authentication data
- Configure RADIUS authentication
  - Configure authentication proxy

### **3.4 Administration and Management**

- Centralized management dashboard
- User provisioning and de-provisioning capabilities
- Role-based access control
- Audit logs and reporting capabilities

### **3.5 Support and Maintenance**

- Technical support for the duration of the contract
- Troubleshooting and issue resolution
- System updates and patches
- Service Level Agreement (SLA) with defined response times

### **3.6 Training and Documentation**

- Provide administrator training to ICT staff
- Provide user guides and system documentation
- Knowledge transfer to internal ICT personnel

---

## **4. Deliverables**

- 250 active MFA licenses
- Fully configured and integrated MFA solution
- Administrator training sessions conducted
- User manuals and technical documentation
- Support and maintenance services for 12 months
- Support cloud-based MFA

## **5. Duration**

The contract will be valid for a period of **12 months** from the date of appointment.

## **6. Minimum Requirements**

Bidders must:

- Be a registered and compliant service provider
- Have proven experience in implementing MFA solutions
- Provide references for similar projects

- Demonstrate compatibility with ESS or similar systems
- Provide a detailed implementation plan

#### **7. IMPLEMENTATION TIMELINE**

Implementation must be completed within 10 working days including configuration, testing and go-live.

#### **8. SERVICE LEVEL AGREEMENT**

The solution must include 99.9% uptime, support, updates, and security monitoring.

## **EVALUATION CRITERIA**

Preferential Procurement Regulations, 2022 issued in terms of section 5 of the Preferential Procurement Policy Framework Act, Act Number 5 of 2000 (PPPFA) as well as Enoch Mgijima Local Municipality supply chain policy will be as follows:

PPPFA – 80/20-point system will be used for point scoring for all the service providers that satisfy the evaluation minimum threshold.

Price - 80

BBBEE - 10

Specific Goals – 10

The bid will be evaluated in three stages namely:

- Stage 1 - Compliance/Administrative Check evaluation
- Stage 2 – Functionality (Capacity and Capability)
- Stage 3 – Price, Locality and BBBEE Certification

### **STAGE 1 COMPLIANCE/ADMINISTRATIVE CHECK**

The first step in bid evaluation the municipality at this stage will ensure bidder comply with all the mandatory requirements outlined in the tender document. Perform the checking of the completeness in the document submitted, check that powers and signatures are valid and confirming the bid complies with a number of general legal requirements. If the bidder does not comply with the above mentioned will be deemed nonresponsive and not being evaluated to the next stage.

## **STAGE 2 FUNCTIONAL /TECHNICAL EVALUATION**

Bidders must score a minimum of 60 **points** to be considered for further evaluation.

Only those bids that attain the minimum threshold score of 60 Points in Stage 2 will be evaluated in this stage. Bids will be evaluated as follows:

#### **TAX CLEARANCE CERTIFICATE AND MUNICIPAL RATES AND SERVICES ACCOUNT**

The Bidder shall supply, with his tender a SARS Tax Clearance Certificate current on day of the Bid, declaring that the Bidder's Tax Affairs are in order.

Should the Bidder not supply the certificate the Bidder will be automatically disqualified.

The Bidder shall also supply proof of the firm that is not in arrears with their Local Municipality rates or service charges by more than 30 days.

#### **VALUE ADDED TAX**
