1. PURPOSE

Nongoma Local Municipality seeks a qualified, experienced and reputable travel agent for the three (3) year period to provide and to assist the municipality with travel and accommodation arrangements.

2. BACKGROUND

The Municipality wants a travel Agency services in order to minimize costs.

3. SCOPE OF SERVICE

The service provider undertakes to conduct the services of air and surface travel, car hire and accommodation reservations on behalf of Nongoma Local Municipality.

4. AVAILABILITY

- The service provider shall conduct business from **7h30 to 16h30**, five days a week
- Shall provide service to the municipality as per the hours stated on the above bullet.

5. EMERGENCY SERVICE AND SUPPORT (24 HOURS)

- The service provider shall provide after hours' emergency service and support to Nongoma Local Municipality on a dedicated phone number (mobile or land line)
- Nongoma Municipality shall utilize the emergency and support service number(s) provided by the service provider for making reservations for emergency and unforeseen circumstances.

6. AIR AND SURFACE TRANSPORTATION

- The service provider shall ensure that all offers shall be aimed at providing the best service to Nongoma Local Municipality
- The service provider shall make frequent follow up contact with the booking official at Nongoma Local Municipality or travellers with regard to waitlist reservations informing them of the progress made.

7. CAR RENTALS

- The service provider shall negotiate on behalf of Nongoma Local Municipality with car rental suppliers at destinations where there is a need for Nongoma Local Municipality officials or representatives to be provided with a service.
- The Service provider shall effect payment to car rental suppliers on behalf of Nongoma Local Municipality.

8. HOTELS AND ALTERNATIVE ACCOMMODATION

- The service provider shall reserve accommodation at economical rates
- Upon cancellation of any accommodation arrangements, notify the relevant supplier immediately to avoid any cancellation charges.

9. DURATION

The duration of the contract shall be the minimum of three (3) years from the date of appointment.

The probation period for the service provider shall be six (6) months. If the municipality is not satisfied with the services of the service provider within the probation period, then it terminates the services of the service provider and appoints another service provider. The service provider will be evaluated based on performance atleast twice a year and prior arrangement will be made regarding such evaluation date.

10. EVALUATION OF THE BID

The following evaluation method will be used:

- After the closing date of the bid invitation, an appointed bid evaluation committee of Nongoma Local Municipality will evaluate the proposals of the bidders.
- The committee will individually evaluate each of the bid proposals received against the approved criteria as stated below.
- All proposals submitted will be evaluated on two (2) categories:
 - Functionality (technical content)
 - Specific goal

Bids are evaluated in accordance with the Preferential Procurement Policy Framework Act (MFMA), using the 80/20 split.

The evaluation of the bids will be conducted in the following stages:

Firstly, the assessment of functionality must be done in terms of the evaluation criteria and minimum threshold value of **75 points**. A bid will be disqualified if it fails to meet the minimum threshold for functionality as per the bid invitation.

During phase two, only the qualifying bids are evaluated in terms of 80/20 preference points systems. 80 points will be used for price only and the remaining 20 points are is for specific goal.

For functionality, the following criteria will be applicable and the maximum value of each criterion is indicated as below:

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
