1. BACKGROUND

2. BACKGROUND TO ASSIGNMENT

2.1 BANKSETA is a Schedule 3A public entity.

2.2 BANKSETA prepares annual financial statements in terms of Generally Recognised Accounting Practice (GRAP).

2.3 BANKSETA utilises SAGE X3 ERP system as its accounting system

3. SCOPE OF WORK

3.1 BANKSETA seeks a financial software system to utilise it for in-house preparation of GRAP compliant annual financial statements.

3.2 The BANKSETA will continue to utilise its SAGE X3 ERP system for accounting up to trial balance stage.

3.3 The service provider should provide training and technical support for the financial software system.

3.4 The service provider should install the financial software system on the laptops belonging to the BANKSETA or the financial software should be accessible through a web-based system

3.5 The financial software system should be on an annual licencing/subscription basis and a separate amount should be indicated in the quote for the support and training.

4. MINIMUM REQUIREMENTS - COMPETENCY AND EXPERTISE REQUIREMENTS

The service provider should submit information requested below. The BANKSETA may disqualify submissions that do not adequately cover all the requirements.

4.1 The service provider should provide the following information about the financial software system proposed to show that it has adequate functionalities.

4.1.1 The financial software system should have standard GRAP wording and templates and disclosure notes and formats inbuilt in line with GRAP.

4.1.2 The financial software system should have the ability to import information in excel from a trial balance and utilise a mapping tool to prepare the statements of financial position, financial performance and most of the notes from this. The service provider should specifically include information about this functionality.

4.1.3 The financial software system should have the functionality to import other information and notes like a commitments summary or leases summary from excel or word and place it as a note in the financial statements.

4.1.4 The financial software system should have the functionality to allow manual adjustments and editing of notes and tables to add or delete details.

4.1.5 The financial software system should flag should the trial balance or any note be out of balance for any reason.

4.1.6 The financial software system should allow more than 2 users to transact on it and live save all details updated. It should also have the functionality for a supervisor to lock a particular version of the information and any changes made after that to be saved in a differently named version.

4.1.7 The financial software system should be able to print out the financial statements at any point in A4 and in PDF.

4.1.8 The financial software system should be able to bring forward prior year figures as comparative figures. The recommended service provider will be requested to demonstrate the above functionality.

4.2 The service provider should provide a list of at least 3 client public entities where it provides/has provided and supports/has supported the financial software system successfully for at least 2 years. These public entities should not be departments or municipalities, and ideally should be national entities for example SETAs, Schedule 3A entities, Schedule 2 entities. The contact details should be given so that BANKSETA may check the information. The following table should be completed.

4.3 The person providing support for the financial software system should have at least 3 years' experience in providing support on the financial software system being offered. The service provider should provide the CV of the person showing this experience.

4.4 The trainer should have at least 3 years' experience in training on the financial software system being offered. The service provider should provide the CV of the trainer showing this experience.

(The BANKSETA retains the right to verify any information submitted.)

5. DURATION OF THE CONTRACT

5.1 The licensing period and support period should be at least 1 year

5.2 The training provided should be at least 5 days

EXPLANATIONS

- 1.1 Black persons are as defined in Broad based black economic empowerment Act (B-BBEE) which currently means Africans, Coloureds and Indians and Chinese (via a court ruling)
- (a) who are citizens of the Republic of South Africa by birth or decent; or
 - (b) who became citizens of the Republic of South Africa by naturalisation –
 - (i) before 27 April 1994;
 - (ii) on or after 27 April 1994 and who would have been entitled to acquire citizenship by naturalisation prior to that date.
- 1.2 Black Person Ownership points will be awarded to a Tenderer who have 51% or more black ownership. The shareholding will determine the ownership.
- 1.3 Women ownership points will be awarded to a Tenderer who have 33% or more women ownership who are South African citizens.
- 1.4 Youth ownership points will be awarded to a Tenderer who have 33% or more youth ownership being persons 35 years and below, determined at the date of tender/ RFQ closing. Youth ownership will be determined based on the shareholding of the members who are defined as youth and are South African citizens.
- 1.5 Small and medium business includes all South African businesses, co-operatives and non-governmental organisations with annual turnover up to R10 million or alternatively, these entities are recently incorporated, have been operating for less than one year and are projected to have annual turnover of less than R10 million in the first year. The ownership of small and medium business, co-operatives or non-governmental organisations should be 100% South African citizens (or entities owned 100% by South Africa citizens).

1.6 An entity may claim points based on the same shareholding or persons in more than one category. For example black female disabled shareholders under 35 who is a SA citizen may lead a business to claim points under Empowerment of women and youth empowerment

1.7 False Information from Bidders

Should the BANKSETA ascertain that any bidder has submitted any false information, the BANKSETA may disqualify the bidder/service provider, cancel any award without prejudice to any other remedies available to BANKSETA and report the service provider to National Treasury.

The bidder/service provider will be given an opportunity to give reasons why BANKSETA should not take actions detailed above where false information has been submitted.

1.8 The points scored by a bidder in respect of the PREFERENCE POINTS UTILISING BANKSETA GOALS contribution will be added to the points scored for price to arrive at the overall score. Points will be rounded off to the nearest 2 decimals. If two or more tenders have scored equal total points, the contract will be awarded to the bidder scoring the highest number of points for the specified goals or PREFERENCE POINTS UTILISING BANKSETA GOALS contribution.

8. RFQ CONDITIONS

- a. BANKSETA reserves the right to withdraw or amend terms of reference by notice in writing by advertising in the media in which the RFQ was originally advertised prior to the closing date.
- b. BANKSETA reserves the right not to award this RFQ and the right to reduce the quantities awarded.

- b) All applications duly lodged as per the submission requirements will be evaluated in accordance with the stipulated evaluation criteria.

10. REASONS FOR REJECTION

- b) BANKSETA shall reject a submission if the applicant has committed a proven corrupt or fraudulent act in competing for a particular contract.
