SECTION 2: BACKGROUND, PURPOSE, AND SCOPE OF WORK

1. Introduction

ACSA airports have been capacitated with single view security screening machines at International and domestic central screening points (CSP) access gates, crew and staff screening points, goods screening points, transfer, and VIP facilitation. These machines have passed their operational life cycle and thus creating potential security risks at various airports. The current and emerging threats have surpassed the single view technology and thus no longer agile enough to tackle the emergent threats, moving bottlenecks and inefficiencies within the system. Further maintenance costs are exorbitant and replacement parts are difficult to source. The current screening equipment at various central search points, access gates and various security-controlled points require replacement from the single view to the latest technology in the market.

ACSA, therefore, request information of the latest advanced screening technology that is currently available on the market that would not require the removal of lags and electronics from carry-on luggage as well as improving the processing rate per passenger (throughput).

2. Purpose

ACSA is soliciting information from relevant service providers to replace the current security screening machines and to implement automated lanes. ACSA would like to implement security screening technology that will be able to detect prohibited items and to mitigate risks and emerging threats across all 9 airports covering the following areas.

- Central Screening Points (International and domestic)
- Crew and staff screening
- Cargo
- Retail goods screening
- Vehicle access gates

3. Objective

The objective of the RFI is for the suppliers to advise on the latest technology in the market and the estimated costs of the Passenger Screening and Detection equipment, screening of goods and supplies (retail), vehicles screening equipment and automated lines at all ACSA airports, implementation, maintenance, training, project management and support as well as the required infrastructure and data security systems that ACSA would need to consider. These estimated costs

will enable ACSA to budget properly for a project of this nature. Furthermore, the supplier is requested to measure and compare market related pricing of the proposed solution/s.

The solution/s must be innovative and add value to the business process management services across the customer value chain, which should also support ACSA's strategic objectives by:

- a) Improve Operational Efficiency
- b) Increase detection levels.
- c) Increase Baggage Security
- d) Improve Focus on Checkpoint Operations on Security Issues
- e) Increase Passenger Throughputs
- f) Enhance Passenger Experience
- g) Ensure future expansion through a Modular Design
- h) Significantly Reduce Security Checkpoint Staffing Levels
- i) Rapid Return on Capital Investment
- j) Low Operating Costs
- k) Measure the Number of Passengers being processed.
- l) Measure the ability of security screening to detect foreign/prohibited objects (both through test blocks and real-time assessment).

4. RFI Scope

The proposed solution and costs estimates should include the following:

Design, Supply, Installation, Reliability Testing, Commissioning, Maintenance & Repairs, Training and Project Management of Security Detection system, Full Body Scanners, Automated Tray Return (ATR) and Centralized Screening System for Hand Baggage. X-Ray Inspection System at ACSA Airports, with two-year on-site warranty and five years Comprehensive Annual Maintenance Contract with 24 hours and 7 days dedicated resource/s deployment, spares (supply of spares) as per terms, conditions, and specifications of the tender.

This is to ensure the replacement of the current equipment with the latest security detection equipment and contact less technologies to enable the following services and systems:

- Cabin Baggage 3D Xray Machine
- Goods and supplies Palletized Xray Machine (bulk screening 100x100 & 150x150)

- Full Body Scanner
- Automated lanes with automated Barcode Reader (Egates)
- Archway Metal Detectors (AMD's)
- Equipment test piece
- 1 x recheck 3D x-ray machine per 2 lanes (reverse system) /secondary reviewing station.
- Central remote screening room
- IT services and integration to ACSA network
- Mobile Vehicle Screening Xray equipment
- RFID trays
- Self-service 2D barcode machines

4.1 Technical Information and Specification:

- 4.1.1 Service Providers are requested to submit their responses via email that clearly set out their proposed solution and estimated costs to each solution in line with the request.

- *Service Providers need to take into consideration that ACSA has 9 airports within South Africa, this is made up of 3 International (bigger) and 6 Regional airports (smaller) therefore the proposed solution should differentiate between equipment that will be proposed for these different sizes of airports.*
- *Service Providers must also indicate if the proposed equipment is ECAC or TSA accredited.*

The information provided must be presented in a format that corresponds to and references sections outlined within this RFI. This will allow ACSA to more easily formulate a budget based on a comparison and extraction of information from all respondents. Each RFI response will be a potential contributor to part of the overall specification formulation, budget and other.
- iii. All responses will be kept confidential and not be available for public knowledge.
- iv. Any irregularities or lack of clarity in the RFI should be brought to ACSA's attention as soon as possible so that corrective addenda may be furnished to prospective respondents.
