## Scope of works (Northern Work Deep Cleaning)

### Provision of deep cleaning services

The service provider will be required to provide deep cleaning services which include but not limited to the following activities.

1. Disinfecting of accumulated germs, removing of mould from grout in showers, floors and tiled walls.
2. Deep cleaning in urinals, shower drains, toilet pans and rims and hand basins as well as odour prevention
3. Service provider will be required to submit deep cleaning report upon completion
  1. The contractor shall provide all deep cleaning equipment, material and for the services required to execute the scope of work throughout the duration of the contract.
  2. The contractor shall provide all necessary machinery, tools and all relevant cleaning materials for the proper execution of the work. Such machinery / equipment and materials shall be suitable for its purpose.
  3. Such machinery / equipment to be provided by the contractor must be in good and safe working order. Sub-standard provision of services due to defective equipment will not be allowed by JW and all work on site must be in accordance with the Occupational Health and Safety Act (85 of 1993) and its regulations with all applicable signs to be provided where required.
  4. A full staff compliment must be always on site when required and contractors staff related issues must not impact on service delivery and must be resolved by contractor and not escalated to JW as this is a relationship between the contractor and their staff. Johannesburg Water will manage the contract at the appropriate level.
  5. Companies are required to provide Materials Safety Data Sheets (MSDS) for the cleaning chemicals used. Copies must be submitted on delivery to the site managers.
  6. All electrically operated equipment shall comply with the relevant South African Bureau of Standards (SABS).
  7. The contractor shall undertake to provide and use environmentally friendly cleaning products / agents / materials as required by Johannesburg Water.
  8. The contractor shall be responsible for the efficient performance of the contract and for the good conduct of their employees whenever they carry out deep cleaning.
  9. The contractor shall maintain a sufficient number of employees at all times to properly fulfill their obligations under this contract.
  10. All employees who are engaged to carry out works under this contract shall at all times, **wear clean and tidy uniforms** and put proper safety signage which shall be provided by the contractor. The staff is to work quietly and refrain from disturbing JW employees while performing work duties.
  11. The JW Regional Manager (RM) or Works Manager (WM) or Finance Officer (RFO), reserves the right to give working instructions directly to the contractor's employees if in the opinion of the RM / WM / RFO it is deemed necessary.
  12. All employees should be observant, keen, alert, efficient, willing and pleasant. The contractor shall provide adequate staff to JW for the

duration of the contract for deep cleaning and hygiene services. All employees shall have proper qualifications / competency required to use and operate the necessary equipment and chemicals when performing these tasks.

- (d) “**tender for income-generating contracts**” means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) “**the Act**” means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

### 3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

#### 3.1. POINTS AWARDED FOR PRICE

##### 3.1.1 THE 80/20 PREFERENCE POINT SYSTEMS

A maximum of 80 points is allocated for price on the following basis:

**80/20**

- Ps = Points scored for price of tender under consideration

## **CERTIFICATE OF INDEPENDENT BID DETERMINATION**
