1. INTRODUCTION

The Winnie Madikizela-Mandela Local Municipality intends to appoint a suitably qualified service provider for the installation of existing street name signs within ward 1, Bizana. The project forms part of the municipality's ongoing initiatives to improve urban management, spatial addressing, public navigation, and accessibility within the municipal area.

Street naming and signage are essential components of municipal spatial management systems and contribute towards improved wayfinding, emergency response services, postal delivery, municipal administration, and overall urban functionality. The installation of street name signs further supports orderly urban development and enhances the identification of public roads within established areas.

This project specifically focuses on the installation of forty-six (46) existing street names within ward 1, Bizana.

2. BACKGROUND & PROBLEM STATEMENT.

The absence of visible street name signs creates challenges relating to:

- Public navigation and accessibility;
- Emergency and disaster response;
- Service delivery coordination;
- Property and address identification;
- Municipal billing and administrative functions; and
- General urban management.

The installation of street name signage is therefore necessary to improve spatial legibility and ensure that approved street names are effectively implemented on the ground. The project further supports the municipality's broader objectives of improving urban functionality and enhancing service delivery within Bizana.

Accordingly, the municipality seeks to appoint a service provider for the manufacture, supply, and installation of forty-six (46) street name signs within ward 1, Bizana.

3. SCOPE OF WORK.

The appointed service provider will be required to undertake the following:

3.1 Site Verification

- Conduct site inspections and verify the location of the identified streets;
- Confirm installation points in consultation with the municipality.

3.2 Manufacture and Supply of Street Name Signs

- Manufacture street name signs in accordance with municipal specifications;

1. Concrete Specifications

The street name signs and supporting structures shall be constructed using reinforced concrete of a minimum strength of 30 MPa (Class 30/19 concrete) at 28 days, suitable for outdoor municipal infrastructure and capable of withstanding weather conditions, vandalism, and long-term exposure and be 2,2meters visible from ground level.

The concrete shall comply with the relevant provisions of the South African National Standards (SANS) and shall possess the following minimum characteristics:

- Minimum compressive strength: 30 MPa at 28 days.
- Concrete mix shall be machine mixed to ensure uniformity and quality.
- Concrete shall be free from honeycombing, cracks, voids, segregation, or other defects.
- Reinforcement shall consist of high-yield steel bars or welded mesh as approved by the Municipal Project Manager.
- All exposed concrete surfaces shall have a smooth and professional finish.
- Concrete shall be adequately cured for a minimum period of seven (7) days to achieve the required strength and durability.
- The service provider shall submit concrete mix designs and material specifications for approval prior to commencement of manufacturing.

2. Foundation Requirements

Each street name sign shall be installed on a reinforced concrete foundation designed to ensure structural stability. Unless otherwise approved by the Municipality, the minimum foundation dimensions shall be:

- Length: 600 mm
- Width: 600 mm
- Depth: 800 mm

The foundation shall be constructed using 30 MPa reinforced concrete and shall be designed to prevent movement, tilting, settlement, or failure under normal environmental conditions. Width of the concrete poles must be 125mm, the width of the plate must be 110mm

3. Engraving and Finishing

- Street names shall be engraved into the concrete to a minimum depth of 10–15 mm. The street names must be on both sides.
- Lettering shall be painted using a high-quality, UV-resistant, weather-resistant black road-marking or masonry paint.
- The (white paint in the background and black paint to engrave) paint shall be applied in not less than two coats to ensure visibility and longevity.
- The finished sign shall be resistant to fading, peeling, cracking, and weather deterioration for a minimum period of five (5) years under normal conditions.

Warranty

The successful bidder shall provide a minimum five (5) year warranty on the concrete structure against structural defects and a minimum two (2) year warranty on the painted lettering against excessive fading or peeling resulting from poor workmanship or inferior materials.

3.3 Installation of Street Name Signs

- Install street name signs at approved locations;
- Ensure all installations are secure, properly aligned, and visible.

The service provider shall:

- Excavate foundations at designated locations.
- Cast and install concrete signs securely.
- Ensure signs are vertically aligned and structurally stable.
- Backfill and compact excavated areas.
- Reinstate disturbed areas to their original condition.

3.4 Completion and Handover

- Submit completion report;
- Rectify any defects identified during municipal inspection.

4. OUTCOMES AND DELIVERABLES.

The service provider will be required to submit the following:

- A detailed and comprehensive project close-out report

5. PROJECT DURATION AND COST

The project time frame will be 4 months from the date of appointment of the service provider.

The project proposal must contain the following:

- Clear project methodology and planning process to be followed.
- Comprehensive company profile and contact person to be responsible for the project
- Clear time frame for the project
- Clear project budget aligned to the tasks or activities.

Undue Delay Remedies

Should it be found that the delay of the project in terms of the agreed time period is unreasonable then for every 5 (five) days or other stipulated time frame there shall be a penalty in terms of percentages which will be deducted from the payment

6. INFORMATION GATHERING

The successful Service Provider is expected to contact all the relevant GIS, Planning and required officials to obtain relevant information that is required for the project. Existing relevant information which is available within the municipality will be made available to the successful service provider.

However, the responsibility for collecting information necessary for the successful execution of the project remains entirely with the service provider.

7. TERMS AND CONDITIONS OF THE BID

7.1 General

Awarding of the bid will be subject to the Service Provider's express acceptance of the municipal Supply Chain Management general contract conditions.

The municipality and Service Provider will sign a Services Level Agreement upon appointment.

Staffing requirements will be identified on the onset of the project and shall remain unchanged for the duration of the project, unless prior written consent has been granted by the Department municipality (Same as 8.4)

No material or information derived from the provision of the services under the contract may be used for any other purposes except for those of the municipality, except where duly authorized to do so in writing by the municipality.

Copyright in respect of all documents and data prepared or developed for the purpose of the project by the Service Provider shall be vested in municipality.

The successful Service Provider agrees to keep all records and information of, or related to the project confidential and not discloses such records or information to any third party without the prior written consent of municipality.

The municipality reserves the right to terminate the contract in the event that there is clear evidence of non-performance and non-compliance with the contract.

The short-listed service providers may be required to do a presentation in person to the municipality; at their own cost should it be deemed necessary to do so.

7.2 Format of Proposal

7.2.1 All proposals are to respond to requirements as per the Terms of Reference

7.2.2 All proposals should be clearly indexed and easy to read

8. EVALUATION PROCEDURE

The 80/20 preference points system as prescribed in the Preferential Procurement Policy Framework Act (PPPFA) will be applied to evaluate this bid. The lowest acceptable bid will score 80 points for price and maximum of 20 points will be awarded for attaining the Broad-Based Black Economic Empowerment (B-BBEE) status level of contribution.

This bid shall be evaluation in two stages. On first stage bids will be evaluated on functionality, second stage in accordance with 80/20 preference points system as stipulated above.

Evaluation of Functionality

Evaluation of submitted proposals is on both price and functionality and 80/20 preference point system will apply:

Functionality [100]

Price [80]

Specific Goals [20]

The bid will be evaluated in two stages namely: stage one; Functionality, stage two; Price and Specific Goals, Bidders who scores less than 70% on stage 1 will not be evaluated further. Only bidders who score 60% or more would be evaluated further and therefore eligible for the award.
