## **TERMS OF REFERENCE**

### **1. INTRODUCTION**

1.1 The South African Qualifications Authority (SAQA) is a public entity listed in Schedule 3A of the Public Finance Management Act (PFMA). It is mandated by the National Qualifications Framework (NQF) Act, 67 of 2008, to oversee the further development and implementation of the NQF, advance the objectives of the NQF and coordinate its three Sub-Frameworks.

1.2 South African Qualifications Authority (SAQA) has a responsibility to ensure adequately and appropriately organised training and development for all staff to ensure the acquisition of the necessary skills, knowledge, and attitudes.

### **2. PURPOSE**

2.1 The purpose of this Request for Quotation (RFQ) is to appoint a training provider to conduct CompTIA Advanced Security Practitioner (CASP+) training and examination for one delegate.

### **3. SCOPE OF SERVICES**

3.1 The appointed service provider must provide CompTIA Advanced Security Practitioner (CASP+) training and examination.

3.2 Bidders are required to submit a brochure or information on the CompTIA Advanced Security Practitioner (CASP+) training and examination, indicating the duration, the level, training modules/ training outcomes and other information applicable to the training.

3.3 Bidders to Submit at least 3x reference letters where CompTIA Advanced Security Practitioner (CASP+) training and examination was conducted over the last 3 years.

### **4. GENERAL REQUIREMENTS**

4.1 The training must be presented online over 1 month with self-paced access.

4.2 The training must be conducted at an advanced level.

4.3 The training must be provided to one delegate.

- 4.4 The training must include an examination voucher to allow the delegate to write the examination after completion of the training.
- 4.5 The quotation presented to SAQA must include all costs and disbursements inclusive of VAT for the training and examination.
- 4.6 The Service provider must be an accredited training provider with relevant SETA and CompTIA to provide the CompTIA Advanced Security Practitioner (CASP+) training and examination.
- 4.7 The training must cover amongst others the below learning outcome:
  - 4.7.1 An advanced-level cybersecurity certification for security architects and senior security engineers charged with leading and improving an enterprise's cybersecurity readiness.

## 5. TIMELINES

- 5.1 The training must be presented online over 1 month with self-paced access.

## 6. EVALUATION CRITERIA

The bid will be evaluated in two (2) stages:

Stage 1: Screening of mandatory documents.

Stage 2: Price evaluation

## 7. STAGE 1: MANDATORY REQUIREMENTS

Bidders **must** comply with this section as it forms the basis of the evaluation of the bidder's proposal.

For a bidder to qualify to be evaluated for Stage 2: Price and Preference Points, **a bidder must not have been disqualified in compliance with the mandatory requirements.**

## **8. STAGE 2: PRICE AND PREFERENCE POINTS EVALUATIONS**

Price and Preference Points Evaluation as follows:

All bidders that have passed the mandatory requirements will be evaluated in terms of the 80/20 system prescribed by SAQA in line with PPR 2022 as follows:

- i. **80** Points for pricing.
- ii. **15** preference points for the company that has at least 51% black ownership.
- iii. **5** preference Points for the company that has at least 30% black woman ownership.

## **SPECIAL CONDITIONS**

### **9. RFQ SPECIAL CONDITIONS**

- 9.1 Bidders must submit the recent National Treasury (CSD) Central Supplier Database's report.
- 9.2 Bidders are required to submit an original or certified copy of the B-BBEE certificate or Sworn Affidavit as per the B-BBEE Act. The SANAS Logo should be visible on the B-BBEE Certificate.
- 9.3 Bidders must complete, sign, and submit the attached SBD 4 and SBD 6.1 forms.
- 9.4 The proposal and required documents must be submitted using the PDF format only, through email to [RFQ@saqa.org.za](mailto:RFQ@saqa.org.za)
- 9.5 In Instances, where brand names are mentioned, SAQA will accept equivalent items that have similar specifications.
- 9.6 The National Treasury's General Conditions of Contract (GCC) will apply and is enforceable on this RFQ.
- 9.7 The RFQ will be evaluated in terms of the 80/20 system prescribed by the Preferential Procurement Policy Framework Act (PPPFA).

### **10. PROTECTION OF PERSONAL INFORMATION**

- 10.1 In this clause, the words "personal information", "processing" and "responsible party" have the meanings ascribed to them in the Protection of Personal Information Act, 2013 (Act No.4 of 2013).
- 10.2 SAQA will comply with the Protection of Personal Information Act, 2013 (Act No.4 of 2013, (POPIA) by lawfully processing personal information submitted by bidders in accordance with the conditions of lawful processing as set out in POPIA.
- 10.3 All bidders must comply with their obligations as set out in POPIA for which they are a Responsible Party before sharing any information with SAQA.
- 10.4 SAQA will not be held liable for any non-compliance with the provisions of POPIA or unlawful processing or sharing of information by a bidder.

- 3.4 The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.
- 3.5 There have been no consultations, communications, agreements or arrangements made by the bidder with any official of the procuring

institution in relation to this procurement process prior to and during the bidding process except to provide clarification on the bid submitted where so required by the institution; and the bidder was not involved in the drafting of the specifications or terms of reference for this bid.

- 3.6 I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.

## PREFERENCE POINTS CLAIM FORM IN TERMS OF THE PREFERENTIAL PROCUREMENT REGULATIONS 2022

This preference form must form part of all tenders invited. It contains general information and serves as a claim form for preference points for specific goals.

### GENERAL CONDITIONS

1.1 The following preference point systems are applicable to invitations to tender:

- the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
- the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

#### To be completed by the organ of state

*(delete whichever is not applicable for this tender).*

- a) The applicable preference point system for this tender is the 90/10 preference point system.
- b) The applicable preference point system for this tender is the 80/20 preference point system.
- c) Either the 90/10 or 80/20 preference point system will be applicable in this tender. The lowest/ highest acceptable tender will be used to determine the accurate system once tenders are received.

1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

- (a) Price; and
- (b) Specific Goals.

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

## DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

### 3.1. POINTS AWARDED FOR PRICE

#### 3.1.1 THE 80/20 OR 90/10 PREFERENCE POINT SYSTEMS

A maximum of 80 or 90 points is allocated for price on the following basis:

### 3.2. FORMULAE FOR DISPOSAL OR LEASING OF STATE ASSETS AND INCOME GENERATING PROCUREMENT

#### 3.2.1. POINTS AWARDED FOR PRICE

A maximum of 80 or 90 points is allocated for price on the following basis:

## POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
  - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system, then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.

(b) recover costs, losses or damages it has incurred or suffered as a result of that person's conduct;

(c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;

(d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and

(e) forward the matter for criminal prosecution, if deemed necessary.
