A set of fully completed tender documents must be submitted on the original documents and remain valid for a maximum of 120 days after the closing date of the tender. A set of tender documents can be obtained at a non-refundable cost of **R200-00 including VAT** for hard copies directly printed by the Municipality and free of charge when provided on pdf via e-mail. Then hard copies will be physically handed only to prospective bidders who produce a receipt for the payment of the tender document at the SCM Offices.

The municipality reserves the right to withdraw any invitation to tender and/or re-advertise or to reject any formal tender or to accept a part of it. The Municipality does not bind itself to accept the lowest or award a contract to the bidder scoring the highest number of points. Potential bidders should note that all projects in terms of this tender may not materialize.

Pre-qualification: Potential bidder(s) must have been operating in the Retail Curio industry for at least five (5) years. Reference letter(s) confirming the 5-years minimum experience, must accompany the bid document submitted. Failure to provide such reference letter(s) on or before bid closure will render the bid non-responsive (please note that the bidder cannot issue their own reference letters).
