1. INTRODUCTION TO THE NRF

The National Research Foundation (“NRF”) is a juristic person established in terms of the National Research Foundation Act, Act 23 of 1998, and a Schedule 3A Public Entity in terms of the Public Finance Management Act. The NRF is the government’s national agency responsible for promoting and supporting research and human capital development through funding researchers, provision of the National Research Platforms, and science outreach platforms/programs to the broader community. The NRF provides these services in all fields of science and technology, including natural science, engineering, social science, and humanities. The NRF delivers its mandate through its internal business units which are both functional and geographical diverse. All contracts flowing from bidding only apply to iThemba LABS Cape Town.

The NRF is a schedule 3A entity under the PFMA (Act 29 of 1999), which is required to plan and report on its activities and organizational performance, and which is to be audited by the AGSA on an annual basis. - Basic and Applied Nuclear Physics Research using Particle Beams
- Research Radiation Biophysics
- The supply of Accelerator-produced Radioactive Isotopes for Nuclear Medicine and Research

3. INVITATION FOR PROPOSAL

iThemba LABS seeks to appoint a reputable Service Provider as required by National Treasury Regulations (NTRs) and Public Financial Management Act (PFMA) through an open and competitive process so that it can realise the benefits of the strategic sourcing which includes, amongst others:

- Reducing the cost of effort and administration
- Minimising price inconsistencies

- Reducing inadequate contract management and service delivery

This Request for Proposal is intended to allow the successful bidder to specify and present their skills, expertise and price for the above-mentioned services to iThemba LABS. Final acceptance of any proposal is not guaranteed, this being the exclusive right of iThemba LABS.

The purpose of this RFP is to invite proposals for the Provision of the Services of a Professional Construction Health & Safety Agent (PrCHSA) to ensure Health and Safety Compliance for a period of 12 months for the Technology and Innovation Platform Building Project Construction phase at iThemba LABS Cape Town **with** the right to cancellation due to non – performance.

4. OBJECTIVES OF iThemba LABS

1.3.4. No facsimile responses will be considered, unless otherwise stated herein.

1.3.5. The responses to this RFQ will be opened as soon as practicable after the expiry of the time advertised for receiving them.

- 1.3.6.** iThemba LABS reserves the right to accept the whole bid/Quotation / proposal or part of your submitted bid/Quotation / proposal or any item or part of any item or accept more than one bid/Quotation / proposal (in the event of a number of items being offered).
- 1.3.7.** iThemba LABS shall not, at the opening of responses, disclose to any other company any confidential details pertaining to the Quotation / proposals / information received i.e. pricing, delivery, etc. The names and locations of the Respondents will be divulged to other respondents upon request.
- 1.3.8.** Each Quotation / proposal shall be valid for a minimum period of ninety (90) days calculated from the closing date.

There is a minimum B-BBEE threshold of Level four (4) for this Request for Proposal. A bidder failing to meet the stipulated B-BBEE threshold is regarded as non-responsive and will be automatically be disqualified.

A Bidder MUST submit a valid B-BBEE certificate/ Sworn Affidavit. To proceed through the stages of the evaluation process, bidders are to meet the minimum status level of 4 above. Therefore its critical to submit valid B-BBEE certificate/Sworn Affidavit

1.6. Evaluation Process.

Evaluation of Quotation / proposals:

- All Quotation / proposals will be evaluated by an evaluation team and SCM for administrative compliance, Functionality, Price and B-BBEE. Based on the results of the evaluation process and upon successful negotiations, iThemba LABS will approve the awarding of the contract to successful bidder.

1.6.1. Evaluation process will be followed:

- The first phase of evaluation is Pre-Qualification Eligibility Criteria (refer to **paragraph 1.5 page 9**)
- The second phase includes evaluation of mandatory and technical criteria (refer to **paragraph Error! Reference source not found. from page 7**).
- The third phase includes the evaluation of Price and B-BBEE status.
 - Pricing Quotation / proposals will only be considered after the technical phase has been adjudicated and accepted.
 - Preference points system: The 80/20 preference point system will be used where 80 points will be dedicated to price and 20 points to B-BBEE status.

1.7. Pricing Proposal:

1.7.1. Pricing proposal must be cross-referenced to the sections in the Technical Proposal.

1.7.2. Price needs to be provided in South African Rand (incl. VAT), with details on price elements that are subject to escalation and exchange rate fluctuations clearly indicated. Companies to indicate if not VAT registered where applicable

1.7.3. Only firm prices* will be accepted during the bid validity period. Non-firm prices** (including prices subject to rates of exchange variations) will not be considered.

1.8. Appointment of Bidder

1.8.1. Appointment as a successful bidder shall be subject to the parties agreeing to mutually acceptable contractual terms and conditions. In the event of the parties failing to reach such agreement iThemba LABS reserves the right to appoint an alternative supplier.

1.8.2. Awarding of contracts will be announced on iThemba LABS website and regret letters will be sent to unsuccessful bidders.

1.9. Communication.

1.9.1. Bidders are warned that a Proposal will be liable to disqualification should any attempt be made by a Respondent either directly or indirectly to canvass any officer or employee of iThemba LABS in respect of this RFP between the closing date and the date of the award of the business.

SECTION 2: BACKGROUND

2.1 Background

iThemba LABS has identified a need to improve its business operations to cater for the needs and expectations of its customers and employees. To achieve this, an efficient and effective technical infrastructure should be in place to enable core business to achieve objectives. Based on its technological competency, Facilities Management is the internal business partner to provide these essential services. Due to the complex nature of some of these services, it is not possible to offer all services in-house, hence the need to outsource other services to external service providers.

Service Required: -

PrCHSA Services to ensure Health and Safety Compliance during the lifespan of the Technology & Innovation Platform Building Project Construction phase at iThemba LABS Cape Town

The service provider must ensure that all work performed and/or equipment used on site complies with the Occupational Health and Safety Act (OHS Act No 85 of 1993 and its Regulations). The service provider must also submit a Health and Safety File after site establishment.

SECTION 3: SPECIFICATIONS

- 3.1. iThemba LABS (Cape Town) requires the services of a qualified and experienced Professional Construction Health and Safety Agent (PrCHSA) to assist with Legislative, Client Health and Safety and project requirement Compliance during the construction phase of its Technology and Innovation Platform (TIP) Building Project.
- 3.2. The required candidate must be:
 - 3.2.1. Qualified Professional Construction Health and Safety Agent (PrCHSA) in terms of Section 18(1)(c) of the Project and Construction Management Professions Act, 2000 (Act No. 48 of 2000)

- 3.2.2. Registered with the South African Council for the Project and Construction Management Professions (SACPCMP) as per the Construction Regulations, GNR. 84 of 07/02/2014, Section 5 (7)(b).
- 3.2.3. Provide proof of a minimum of 10 Years' experience in projects similar in value (R 8M) and type of that of iThemba LABS TIP Construction Project.
- 3.3.** The PrCHSA will be required to:
- 3.3.1. Compile a suitable, sufficiently documented and coherent site-specific Health and Safety specification for the TIP construction project to ensure that the inclusive Health and Safety and protection of all stake holders involved are considered and catered for.
- 3.3.2. Apply for construction permit in terms of the Construction Regulations, GNR. 84 of 07/02/2014, Section 3 of the Occupational Health and Safety Act, no. 85 of 1993
- 3.3.3. If required, provide Notification of construction work in terms of section 4 of the Construction Regulations of the Occupational Health and Safety Act, no. 85 of 1993
- 3.3.4. Assess and approve Health and Safety Plan/s of the Principal Contractor.
- 3.3.5. Bi-weekly (or monthly) Health and Safety Audits and prepare Reports on Principal Contractor activities as required by Construction Regulations, section 5(1)(o).
- 3.3.6. Monitoring Construction site Health and Safety standards.
- 3.3.7. Managing Construction Health and Safety compliance on behalf of the Client (iThemba LABS).
- 3.3.8. Attend one site meeting per month to convey Health and Safety information to the Client.
- 3.3.9. Stop any contractor and / or Sub-contractor for non-compliance to Health and Safety and Construction Regulations requirements and ensure implementation of all corrective measures.

Responsive bids will firstly be evaluated on functionality. The minimum score for functionality is 60% and a bidder who scores below this minimum will be disqualified automatically from further evaluations.
