The stored fungal collection is vital for ongoing and future research studies. Fungi must be kept in the fridge to enhance the chances of survival. Other reagents and chemicals that must be kept separate in the bar fridge should be kept separate from fungal cultures due to contamination of work. Therefore, a separate upright all fridge is required to ensure accurate and reliable results.
