- Respondents found to be in collusion with one another will be automatically disqualified and restricted from doing business with organs of state for a specified period.

This scope entails the inspection and repairs to defects noticed in Foskor private sidings from Set 1 to Set 28 according to SANS 3000-2-1, SANS 3000-2-2, SANS 3000-2-3 and SANS 3000-2-4 and all application standard requirement(s)

**2. EXECUTIVE OVERVIEW**



**THE NATIONAL INDUSTRIAL PARTICIPATION PROGRAMME****INTRODUCTION**

The National Industrial Participation Programme (NIPP), which is applicable to all government procurement contracts that have imported content, became effective on 1 September 1996. The NIP policy and guidelines were fully endorsed by the Cabinet on 30 April 1997. In terms of the Cabinet decision, all state and parastatal purchases / lease contracts (for goods, works and services) entered into after this date, are subject to the NIPP requirements.
