- Respondents found to be in collusion with one another will be automatically disqualified and restricted from doing business with organs of state for a specified period.
- FOSKOR will publish the outcome of this RFP in the National Treasury e-tender portal, CIDB i-tenderportal (where applicable) and the FOSKOR website within 10 days after the award has been finalised. Respondents are required to check the FOSKOR website for the results of the tender process. - reject any Proposal which does not conform to instructions and specifications which are detailed herein.
- disqualify Proposals submitted after the stated submission deadline 24 June 2025;
- award a contract in connection with this Proposal at any time after the RFP's closing date;
- award a contract for only a portion of the proposed Goods/Services which are reflected in the scope of this RFP;
- split the award of the contract between more than one Supplier/Service provider, should it at Foskop's discretion be more advantageous in terms of, amongst others, cost or developmental considerations;
- cancel the bid process;
- validate any information submitted by Respondents in response to this bid. This would include, but is not limited to, requesting the Respondents to provide supporting evidence. By submitting a bid, Respondents hereby irrevocably grant the necessary consent to Foskop to do so;

**10. LEGAL REVIEW**

A Proposal submitted by a Respondent will be subjected to review and acceptance or rejection of its proposed contractual terms and conditions by Foskor's Legal Counsel, prior to consideration for an award of business. A material deviation from the Standard terms or conditions could result in disqualification.

**11. SECURITY CLEARANCE**

**13. TAX COMPLIANCE**

### SECTION 3: BACKGROUND, OVERVIEW AND SCOPE OF REQUIREMENTS

#### 1. BACKGROUND

This scope entails the inspection and repairs to defects noticed in Foskor private sidings from Set 1 to Set 28 according to SANS 3000-2-1, SANS 3000-2-2, SANS 3000-2-3 and SANS 3000-2-4 and all application standard requirement(s)

#### 2. EXECUTIVE OVERVIEW

Whereas Foskor is seeking a partner(s) to provide solutions nationally, it also seeks to improve its current processes for providing these Goods/Services to its end user community throughout its locations.

The selected service provider(s) must share in the mission and business objectives of Foskor. These mutual goals will be met by meeting contractual requirements and new challenges in an environment of teamwork, joint participation, flexibility, innovation and open communications. In this spirit of partnership, Foskor and its service provider(s) will study the current ways they do business to enhance current practices and support processes and systems. Such a partnership will allow Foskor to reach higher levels of quality, service and profitability.

Specifically, Foskor seeks to benefit from this partnership in the following ways:

### **3. SCOPE OF REQUIREMENTS**

1. Check and lubricate all turnout from Set 1 to Set 28
2. Check if all bolts on the fish plates are fastened and tightened.
3. Check if all bolts on the turn out are fastened
4. Check turnout switch blades at nose to close enough and properly.
5. Check linkages and all rods and split pins to be opened
6. Check condition of sleepers
7. Check clearance mark is painted and clearly visible and re-paint where necessary
8. Check chains and lock on turnouts.
9. Check sign boards if in right places according to standards, straighten if necessary.
10. Check turnout numbers for visibility and repaint if necessary.
11. Check rails for rust and report defects.

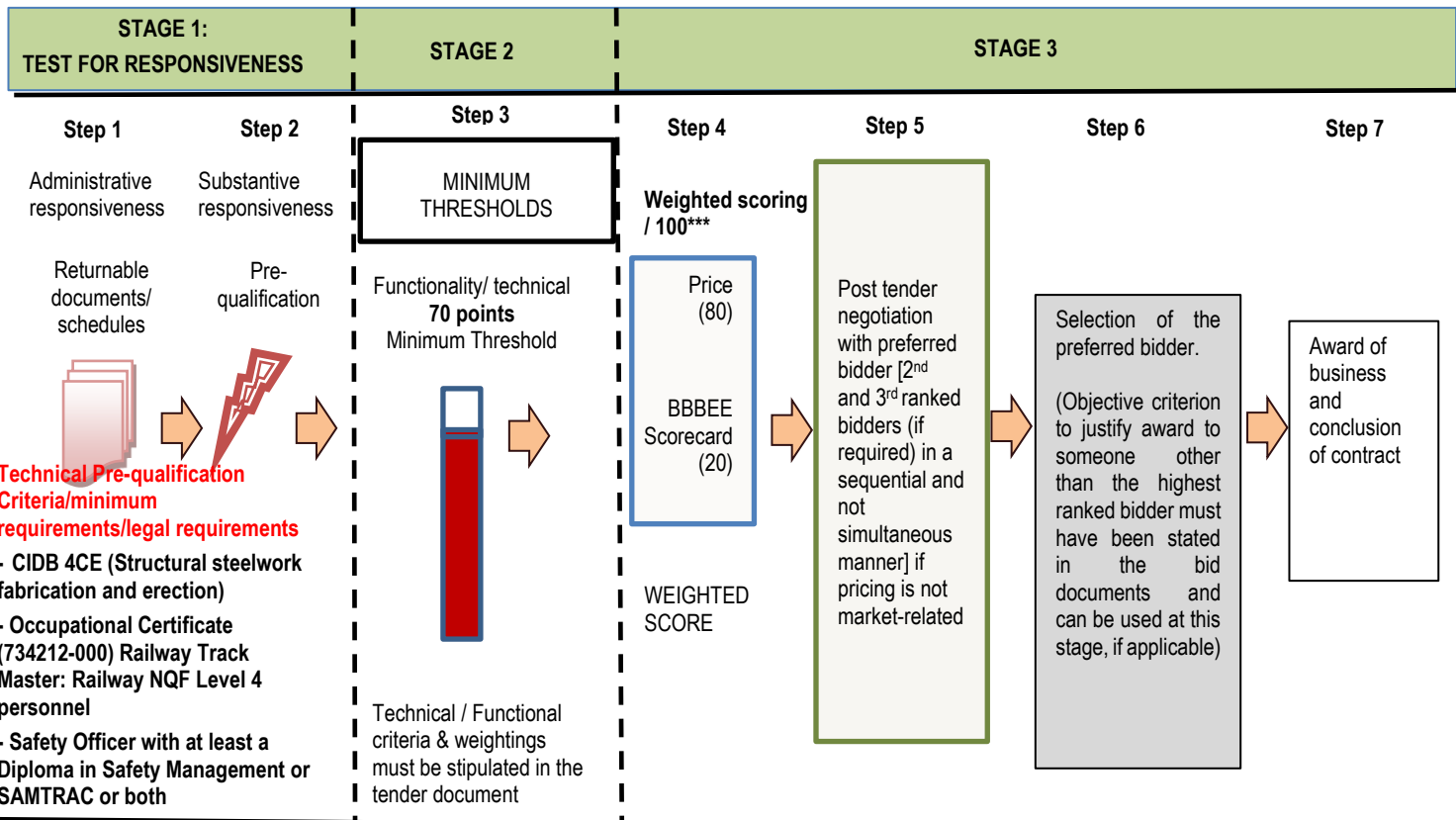

### THE NATIONAL INDUSTRIAL PARTICIPATION PROGRAMME

#### INTRODUCTION

The National Industrial Participation Programme (NIPP), which is applicable to all government procurement contracts that have imported content, became effective on 1 September 1996. The NIP policy and guidelines were fully endorsed by the Cabinet on 30 April 1997.
