- Prices quoted must be firm and must, where applicable, be inclusive of VAT.
- Masilonyana Local Municipality does not bind itself to accept the lowest bid or any other bid and reserves the right to accept the whole or part of the bid.
- Bids that are late will not be considered.
- Faxed or E-mailed bids will not be considered.
- Tax status will also be verified against the Central Supplier Database (CSD).
- A minimum of 50% ownership should be held by someone with professional ECSA registration of Pr Eng or Pr Tech (in case of more than two directors, majority shareholders should be ECSA registered as Pr Eng or Pr Tech)
- Bidders must be registered on the National Treasury Central Suppliers Database and must submit their registration summary report.
- All supplementary / compulsory forms (MBD Forms) must be completed and signed in full.
- It should be noted that the 80/20 principle where 80 Points is for the Price and 20 points for Specific Goals will be applied.
- Company's latest and Valid Municipal Rates and Taxes that is not more than 90 days outstanding, and (in the case of a lease agreement, bidders must attach both the lease agreement as well as the latest and valid municipal rates and taxes of the landlord that is not more than 90 days outstanding) must be attached.
