1. PURPOSE

The purpose of this Request for Quotation (RFQ) is to formally invite suitably qualified and experienced service providers to submit quotations for the provision of accredited Field Guiding Training services at West Coast National Park.

2. INTRODUCTION TO SANPARKS

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

3. RFQ OVERVIEW

The appointed service provider will be required to render the services in accordance with the scope of work, contractual terms, and performance requirements as set out in this RFQ, and to ensure full compliance with all applicable legislative, regulatory, and Supply Chain Management (SCM) prescripts.

This procurement process is conducted in line with CATHSSETA and SANParks Supply Chain Management policies, the Public Finance Management Act (PFMA), 1999, Treasury Regulations, and relevant National Treasury Practice Notes, with the objective of ensuring fairness, transparency, competitiveness, and value for money.

4. SCOPE OF WORK

A suitably accredited service provider is required to deliver a customised Field Guiding Training Programme to twenty-three (23) learners in the West Coast National Park area. The training programme must be aligned to registered unit standards and comply with the requirements of CATHSSETA.

5.1 Background

The Culture, Arts, Tourism, Hospitality and Sport Sector Education and Training Authority (CATHSSETA), in collaboration with South African National Parks (SANParks), is implementing a high-impact skills development project aimed at addressing priority sector skills needs and supporting sustainable employment within the tourism and conservation value chain.

This collaboration forms part of CATHSSETA's strategic initiative to support high-impact projects that contribute to sector transformation, capacity building, and alignment with national skills development priorities, including the National Skills Development Plan (NSDP).

SANParks, as a key implementing partner, brings sector-specific expertise and operational capacity to support the effective delivery of the project. The partnership seeks to ensure value for money, compliance with applicable legislative and regulatory frameworks, and the achievement of intended project outcomes.

In support of the implementation of this initiative, a Request for Quotation (RFQ) is hereby issued to invite suitably qualified and experienced service providers to submit quotations for the provision of the required services, as detailed in this document.

5.2 Objectives:

- To provide face to face theoretical training over a maximum period of 3-4 months, including Saturdays where possible.
- To monitor progress of practical training at host employer's sites.

5.3 Deliverables:

- Provide all required training material for the duration of the training.
- Deliver the training in line with the required hours stipulated in the skills programme outline.
- Register learners with the relevant ETQA within a month of programme commencement.
- Upload learners on the Cathsseta system.
- Submit signed attendance registers and progress reports to the client monthly by an agreed date.
- Represent training provider in the relevant steering committee.
- Ensure learners are certified as competent within 6 months of commencing with the programme and/or a remedial plan is in place for those who might not meet the requirements.
- Issue statements of results and submit a close out/evaluation report at the end of the training.
- Handle the administrative process of booking learners for assessments.

OTHER IMPORTANT INFORMATION TO NOTE:

- Learners will also be staying in the same site as the trainer.
- Facilitator travelling costs will be incurred by the appointed service provider.
- Training material will be the property of the client.

13. FINANCIAL PAYMENT

Payment will be made in accordance with the PFMA (within 30 days of receipt of invoice) after delivery of service rendered or goods delivered.

14. FINAL AWARD

SANParks recommends the bidder who has quoted on all the items as required in terms of the RFQ for the contract award subject to the bidder having supplied the relevant administrative documentation and complied in all aspects with the terms and conditions and requirements of the RFQ. Final award will be confirmed by issuing a PO.

PHASE: 3: TECHNICAL/FUNCTIONAL EVALUATION CRITERIA

(b) Specific Goals.
