Introduction

The FPB is a state-owned media content regulation authority in South Africa. The FPB is mandated by an act of parliament, the Films and Publications Act of 1996 (FP Act). The FPB is an entity of the Department of Communications and Digital Technologies (DCDT).

Films and Publications Act (96 of 1996) guides the mandate of the FPB. Section 2 of the Act sets out its aim and objectives, that is, “to regulate the creation, production, possession and distribution of films, games and certain publications”. The FPB executes this mandate through advising adult consumers “...to make informed viewing, reading and gaming choices, both for themselves and for children in their care” (Section 2A). This provision is meant to protect children from premature exposure to and consumption of disturbing and harmful materials as well as adult experiences (Section 2B). Further, the Act sanctions punishment for the use of children in and exposure of children to pornography (Section 2C). This particular focus on children has been necessitated by the realisation that the public, and young children, are increasingly active in the online space, generating, storing and distributing their own content, which opens everyone up to online dangers.

Purpose of tender

The purpose of the request is to appoint an interim service provider for Off-site storage of FPB records for a period of 18 months.

Scope of deliverables

- Storage space must comply with the Occupational Health and Safety (OHS) Act, Protection Of Personal Information Act, as well as the National Archives Act



regulations which provide for fire detection and prevention, HVAC, shelving, as well as other proper security requirements that outsourced companies comply with fully.

- A secure off-site storage & retrieval of FPB records to ensure that FPB knows where the files/ documents are at all times.
- Disaster recovery plan & backup plans for the documents stored at the off-site facility.
- Retention management system to allow FPB access to the inventory of its records.
- File management system for storing, arranging and managing records.
- Provide user licenses for the File Management System.
- Provide user training and support on File Management System.
- Provide files, boxes, box lids, box labels and other relevant stationery for onsite storage.
- Transportation – The service provider will be required to collect the records at FPB Head Office in Centurion and deliver to their storage facility (enclosed transport/ vehicle with canopy).
- Collection of 2712 boxes from current service provider, 28 kms away from Head office.
- Digitisation of video cassettes (Approximately 300 VHS)
- Destruction Services when needed:

The Service Provider shall against the receipt of written and/or electronically transmitted instruction from FPB destroy any of the files. FPB shall be solely responsible for the consequences of the destruction of files and shall likewise be solely responsible for determining the date upon which files are destroyed.
- Assist with Records Management Policy reviews when required.
- Location: Pretoria or Midrand.
