PART 1A: AMENDMENTS TO TENDER DOCUMENTS (BOOK 1)

List of Contract Documents, Section: Notes to Tenderers:

1. Part T1, Section T1.1:

- First sentence after the heading TENDER NOTICE AND INVITATION TO TENDER replace “17 March 2023” with “24 March 2023”.
- First sentence after the heading, CLOSING TIME, COMPLETION AND DELIVERY OF TENDERS replace “17 March 2023” with “24 March 2023”.

2. Part T1, Section T1.3:

- Clause Number C.2.15.2 replace “Friday, 17 March 2023” with “Friday, 24 March 2023”.
- Clause Number C.3.4.1 replace “17 March 2023” with “24 March 2023”.

3. Part T2, FORM A13:

- The form with the closing date of 17 March 2023 replaced with new Form A13 reflecting closing date as 24 March 2023.

4. Part T2, Section T1.2:

Add Clause C.2.16.2:

“Should the tenderer not accept the validity extension or if the tenderer does not withdraw a condition attached to a conditional acceptance, this shall result in a non-responsive tender, or the tender is considered to have made an election to exclude itself from the tender process.”

5. Part T2, Section T1.2:

Replace Clause C.3.4.1 with the following:

“The time for opening of the tender offers via live streaming or at Western region offices are:

Time: 11h00 on Friday 24 March 2023.

Location: A live link to the opening of tenders will be sent to tenderers who complete and submit form A1.1 and at Western region office, 1 Havenga Street, Oakdale, Bellville, 7530”.

6. Part C1, Section C1.2.2

Under clause 5.9, delete the following sentence:

‘The Performance Guarantee must be provided within 14 days of written acceptance by the Employer of the tender offer. The amount of the Performance Guarantee is 5% of the accepted tender sum for the design portion of the contract (including VAT).’
