TERMS OF REFERENCE FOR THE SUPPLY AND INSTALLATION OF UNINTERUPTED POWER SUPPLY FOR THE SOUTH AFRICAN DIAMOND AND PRECIOUS METALS REGULATOR

1. INTRODUCTION

The SADPMR wishes to appoint a service provider to supply and install uninterrupted power supply (UPS) inside the server room located at the second floor.

2. OBJECTIVE

The main objective of this project is to ensure that all SADMPR offices is connected to the UPS and ensure that it is fully functional in order to protect the infrastructure from being damaged as a result of power interruptions.

3. BACKROUND

The SADPMR requires supply and installation of a new UPS of 160KVA to cater for both first and second floor offices including Sever room, DVR room with Security equipment, patch rooms and boardrooms.

Currently the server room is fitted with 20KVA UPS and batteries that needs to be disassembled by the appointed service provider and install the new UPS.

SADPMR is occupying two floors (ground and first floor). All offices are fitted with dedicated UPS power plugs for everyday use. The building is fitted with backup generator in case of power cut, however the UPS is required to serve as backup between the interface of municipal power interruption and backup generator.

4. SCOPE OF WORK

The installation of UPS system will greatly reduce the vulnerability of the infrastructure within the server room, patch rooms DVR room and DEEC in the event of power interruption, as currently there is no functioning UPS at the mentioned critical areas.
