## 1. BACKGROUND

TASEZ seeks to appoint a suitable service provider for the provision of once-off repair, maintenance and servicing of Fire Detection and Suppression Equipment for all common areas and tenant facilities within the SEZ.

## 2. INVITATION TO SUBMIT A QUOTATION

2.1. This Request for a Quotation (RFQ) is for the appointment of a suitable and experienced service provider to perform once-off repair, maintenance and servicing of Fire Detection and Suppression Equipment for all common area and tenant facilities within the SEZ.

## 3. SCOPE OF WORK

**TASEZ** hereby invites proposals from suitably qualified bidders for the provision of ONCE off repair, maintenance and servicing of firefighting equipment for all common areas and tenant facilities within the SEZ in accordance with relevant SANS and manufacturer recommendations.

The Firefighting Bill of Quantities is as follows:

- Firefighting (wet services) Equipment

### **The pump rooms consist of the following: Phase 1**

- 2x 11KW Grundfos CR15-10 Jockey pumps 400vac 3ph
- 2x Diesel Fire Pump – also type KSB ETA-B 200-500 directly coupled to a Weichai 6-cylinder 12540cc diesel engine.
- Pump has a capacity of 11500 liters/min at a head of 100 meters at 1800 rpm.
- The pump room controls are 2x 24v standalone controller complete with pump and 20-line annunciator control also fitted with a RS1000 Cell Link communicator.
- Higher zone pressure 1200kpa
- 2x Water tank effective capacity is 759 cub.m

Maintain equipment in accordance with SANS and Manufacturer recommendations.

Ensure adherence to all relevant Client Environmental, Health, and Safety Regulations, Code of Conduct, and Policies and Procedures

Ensure adherence to all relevant South African Laws and Regulations, Equipment general design standards, SANS, OHS Act, National Construction and Building Regulations

Ensure all statutory inspections are carried out.

Execute Planned Preventative Maintenance Schedule provided by TASEZ.

Perform any other function as it will be required by TASEZ.

**Equipment and Materials**

All required repair and service consumables and parts will be supplied by the bidder/service provider. This includes the repair equipment.

--

Service providers are to provide their own tools and equipment as may be required during the during the execution of said repairs.

The service provider is expected to manage materials and consumables to ensure that enough back-up repair consumables, materials and equipment specifically essential items are kept on-site in case of sudden shortage (methods are to be included within the contingency section of the Work Plan to be provided).

All repairs need to be of an acceptable quality standard. An acceptable quality standard would be equipment that meets any relevant regulative prescripts and laws within the Republic of South Africa.

TASEZ will inspect the condition of the following prior and post the execution of said repairs and maintenance services.

It is the responsibility of the bidder to ensure that all details as requested are completed, accurate, and comprehensive as this will determine whether the service provider has the capacity available during services.

The service provider shall be responsible for the maintenance of all tools and equipment during the rendering of the repair services.

The service provider must ensure that defective equipment will either be replaced or repaired within 12 hours from the time that such defective equipment is reported by TASEZ and/or the Service Providers staff.

#### **4. CONTACT AND COMMUNICATION**

- 4.1. All communication and enquiries shall be **in writing** (via email), to the following email address, [rfqs-rfps@tasez.co.za](mailto:rfqs-rfps@tasez.co.za). TASEZ will communicate with all Bidders where clarity regarding this RFQ is sought.
- 4.2. **Clarification questions from bidders will be closed two (2) days before date of closure on the RFQ.**
- 4.3. Any communication to an official in respect of the RFQ between the closing date and the award of the contract by the Bidders is prohibited.

- 4.4. If a Bidders finds or reasonably believes it has found any discrepancy, ambiguity, error or inconsistency in this RFQ or any other information provided by TASEZ (other than minor clerical matters), the Bidders must promptly notify TASEZ in writing of such discrepancy, ambiguity, error or inconsistency in order to afford TASEZ an opportunity to consider what corrective action is necessary (if any).
- 4.5. Any actual discrepancy, ambiguity, error, or inconsistency in the RFQ or any other information provided by TASEZ will, if possible, be corrected and provided to all Bidders without attribution to the Bidders who provided the written notice.
- 4.6. All people (including Bidders) obtaining or receiving the RFQ and any other information in connection with the RFQ must keep the contents of the RFQ and other such information confidential and not disclose or use the information except as required for the purpose of developing a response to the RFQ.

**5. LATE SUBMISSION**

- 5.1. Late responses to the RFQ will not be accepted.
- 5.2. All dates and times in this RFQs are in accordance to the South African standard calendar and time.**
- 5.3. Any time or date in this RFQ is subject to change at TASEZ's discretion. The establishment of a time or date in this RFQ does not create an obligation on the part of TASEZ to take any action or create any right in any way for any Bidders to demand that any action be taken on the date established.
- 5.4. The Bidders accepts that, if TASEZ extends the deadline for the RFQ submission (the closing date) for any reason, the requirements of this RFQ otherwise apply equally to the extended deadline
