DETAILED TECHNICAL SPECIFICATION

1. BACKGROUND

The SABC requires a solution for Radio Outside Broadcasts and home broadcasts as the current ISDN technology is being phased out and replaced by Voice over Internet Protocol (VoIP). Currently, ISDN is the main means of getting contributions from various venues to the SABC base site for broadcast through fixed hardwired lines. Internet Protocol (IP) technology is changing the broadcast industry by sweeping aside traditional approaches that relied on a mass of point-to-point cable connections, with each restricted to transporting a given type of media\ data between 2 locations and replacing it with network connections that allow different types of media and data over the same connection. VoIP uses the internet protocol, by converting audio into compressed digital signals, which are then sent to the internet; and has opened the door to greater flexibility and geographical freedom.

The SABC is therefore looking for a Software Application and Hardware that will allow VoIP Broadcasting from an Outside Broadcast or Presenters home for Home Broadcasts. The solution provided should be able to use different types of internet connections for the voice over IP transmission.

9 CONDITIONS TO BE OBSERVED WHEN TENDERING

- 9.1 The Corporation does not bind itself to accept the lowest or any tender, nor shall it be responsible for or pay any expenses or losses which may be incurred by the Tenderer in the preparation and delivery of his tender. The Corporation reserves the right to accept a separate tender or separate tenders for any one or more of the sections of a specification. The corporation also reserves the right to withdraw the tender at any stage.

9.2 No tender shall be deemed to have been accepted unless and until a formal contract / letter of intent is prepared and executed.

9.3 The Corporation reserves the right to:

Not evaluate and award submissions that do not comply strictly with his RFQ document.

Make a selection solely on the information received in the submissions and

9.3.1 Enter into negotiations with any one or more of preferred bidder(s) based on the criteria specified in the evaluation of this tender.

9.3.2 Contact any bidder during the evaluation process, in order to clarify any information, without informing any other bidders. During the evaluation process, no change in the content of the RFQ shall be sought, offered or permitted.

2 SUB-CONTRACTING

- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
