## SECTION 2: BACKGROUND, PURPOSE, AND SCOPE OF WORK

### 2.1 Background and/or Purpose of this Bid

Airport Company South Africa was formed to own and operate the nine principal South African airports, including the three main international gateways of O.R. Tambo, Cape Town and King Shaka International Airports. As a State-owned company, Airports Company South Africa has a greater mandate than simply deliver profitability for its shareholders. ACSA is mandated to advance South Africa's national agenda of economic growth and development while delivering a sustainably profitable business.

Airports Company South Africa has two distinct revenue streams, which have generated income for the past few years. One source is defined as aeronautical income and is derived from regulated charges or tariffs. These consist of aircraft landing and parking charges, and passenger service charges.

The non-aeronautical income is generated from commercial undertakings and flows from retail operations, car parking, car rental concessions, advertising, property leases and hotel

operations. According to research these commercial undertaking made almost 48.1% of the total revenue generated by the airport.

Since the Covid-19 pandemic the number of passengers passing through the airports has reduced and most of the national airlines have since been grounded or put under business rescue. This has negatively affected the revenue streams of the airport operators and it necessitate the operators to look for alternative ways to bolster their revenues.

## **2.2 Scope of Work**

The Airport Company of South Africa (ACSA) is seeking a Partner to monetize mobile/telecoms/ICT infrastructure including the shared multi-operator's platform/s at the airports.

Typical ICT infrastructure to be considered are the current and future network connectivity infrastructure, Physical infrastructure, telecommunications (voice and data). ACSA has also considered revenue shared agreements for base stations built on its properties.

The world's busiest airports have tens of millions of passengers passing through in arrivals, departures and transit every year. Passengers expect a seamless and abundant wireless experience at the airport, moreover, network designs must enable coverage and capacity to accommodate the high traffic conditions. In order to seamlessly provide services to these passengers, multiple telecommunications, including mobile operators have deployed their base stations at the airports to capture the passengers on their networks. This is increased revenue to the operator especially the international passengers who will be roaming on their networks.

These telecommunications operators are leasing space from the ACSA for the infrastructure and in turn generate revenue and ACSA generate its revenue only through tenant leases.

The respondents must propose revenue share model on innovative solutions, programs and plans to improve the management and operation of the multi-operator ICT infrastructure as well as monetising current available infrastructure already deployed.

Upon appointment of the successful bidder, an Agreement, on ACSA's contract template, will be concluded for 10 years (120 months). ACSA may at any time, terminate the Agreement or postpone or delay all or any part of the contract upon written notice to the successful bidder in line with the prescribed process.

## SECTION 3: EVALUATION CRITERIA

### 3.1 Evaluation Criteria

3.1.1 ACSA will use a pre-determined evaluation criteria when considering received bids. The evaluation criteria will consider ***mandatory administrative, functionality/technical, and price and preference***. During the evaluation of received bids ACSA will make an assessment whether all the bids comply with set minimum requirements and whether all returnable documents/information have been submitted. Bidders which fail to meet minimum requirements, thresholds or have not submitted required mandatory documents will be disqualified from the bid process.

3.1.2 The requirements of any given stage must be complied with prior to progression to the next stage. ACSA reserves the right to disqualify bidders without requesting any outstanding document/information.
