	Q: Some items on the BOQ do not have technical specifications, like sizes. For example,		
	item number 17.57 has no cable size.		
	A: Cable sizes cannot be determined without a detailed design because cable sizing		
	depends on multiple critical factors that are specific to the installation and		
	operational conditions. The cable length that depends on the selected route will affect		
	the cable sizing significantly, (length and permissible voltage drop, environmental		
	conditions). Please note that an allowance has been made for the provisional sum in		
	the amended BOQ		
	Q: There was a mention of the supply and installation of a backup power supply, but it is		
	not in the BOQ, as well as the separate power factor correction for the substation		
	A: Please note that an allowance has been made for the provisional sum in the		
	amended BOQ.		
	Q: We request clarity on the ISO certificate. Do you require one or two certificates for		
	JV, or will one suffice?

	<ul> <li>the combined Contractor grading designation calculated in accordance with the Construction Industry Development Regulations is equal to or higher than a contractor grading designation determined in accordance with the sum tendered for a 8EP or higher class of construction work or a value determined in accordance with Regulation 25(1B) or 25(7A) of the Construction Industry Development Regulations</li> </ul>	
	<ul> <li>The tenderer shall provide a certified copy of its signed joint venture agreement</li> </ul>	
	<ul> <li>Lastly, it is a CIDB condition that all members of a JV shall be registered with the CIDB.</li> </ul>	
	Q: If the bidder has failed in one of the stages i.e. stage 1 and step three substantive	
	responsiveness, will the bidder be disqualified and not evaluated further to the next	
	stage of evaluation?	
	A: Yes, any tenderer that fails to meet the stipulated eligibility criteria will be	
	regarded as an unacceptable tender and will not be evaluated further to the	
	functionality stage. The same applies to tenderer that fails to meet the minimum

	threshold of 60 in functionality will not be evaluated further in preference point	
	system. Essentially various evaluation gates must be passed, and if not, the tender	
	is not evaluated further. All tenderers passing stage for Functionality will be	
	evaluated on Price & Specific Goals and ranked from highest scoring to lowest. The	
	highest scoring tenderer will, on the face of it, be the "1st ranked tenderer" -	
	subject to Probity reports, Risk Assessments and Objective Criteria (if applicable).	
	Q: Would a Project manager's qualification or registration with the Project Management	
	Institute, but not with SACPCMP, be accepted?	
	A: No, only Construction Project Managers who has obtained a valid registration with	
	the South African Council for the Project and Construction Management Professions	
	(SACPCMP) as a Professional Construction Project Manager, will be considered as	
	per the technical evaluation criteria in the RFP.	
	Q: If the Company/ JV is not ISO Certified but already busy with the Final Audit for ISO , will	
	they be disqualified?	
	A: Yes, they will be disqualified.
