Dube TradePort Corporation (DTPC) was created as a provincial public entity to develop Dube TradePort. Refer to www.dubetradeport.co.za for more information on DTPC.

DTPC invites service providers to supply and deliver nine (9) new forklifts; provide on-site planned and reactive maintenance services and spare parts over a period of three (3) years. The service provider must buy back the existing six (6) forklifts.

EVALUATION OF THIS BID

All proposals will be evaluated in various stages – compliance and functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2022 using the 80/20 preference points system.

The 20 preference points will be allocated to the following as per the split included in the bid document:

- i. Enterprises (or bidders) who are at least 51% Owned by Black People.
