

SCOPE OF WORK – SECURITY SERVICES

Minimum requirements to be met by the supplier/bidder

- National footprint
- National control room
- Trained riot reaction unit
- Trained armed reaction units

The scope of work is as follows:

- Physical Security at Salvokop and Harmony Bus Depots (Access control – Staff, third parties, vehicles, assets).
- Crime Prevention.
- Asset protection (Busses and Facilities).

Perimeter control

- Substance Abuse testing (Breathalyser Testing)
- Searching / scanning of vehicles / visitors and staff entering and exiting depots

Physical Security for Salvokop and Harmony Depot:

Perimeter security, access control, alarms (intruder detection), surveillance, physical security requirements, and asset protection;

Analyse crime statistics and trends to inform Autopax on measures to be taken to reduce the security threats at the depot.

Prevent crime at Harmony and Salvokop Depots;

Respond to and report incidents;

Provide first class customer service to any visitors and clients coming onto Depot premises.

Arrest and hand over criminal perpetrators to SAPS.

Protect Autopax assets and information and check credentials of people and vehicles entering and leaving Autopax premises.

Maintain order and protect Autopax customers, staff, and property.

Conduct security checks over a specified area.

Utilising technology solutions to reduce crime incidents, asset losses and interruption of ~~services~~ – Electronic monitoring of entrance and exit gate and perimeter.

Conduct regular patrols to ensure protection of Autopax assets from theft and damage (Clocking points).

Firearms handling and securing thereof.

Armed response reaction to emergencies.

Surveillance and patrol.

Substance Abuse Testing using Alco-blow Breathalyzer Machine (Alco-blow Torch and Lion 600 -Printing Machine)

Insurance

Security company will be held liable for any loss to Autopax because of non-performance or negligence by any of the employees

Supplier/Bidder to submit proof of insurances

Guards

AUTOPAX will primarily utilize Grade C Armed and Unarmed Security officials **(provide PSIRA certification for the guards)**, other categories of Security officials may be required as informed by the security risks and threats including sites where National Key Point (NKP) standards may be implemented and where other specified grades may be required.
