The Senqu Municipality does not bind itself to accept the lowest tender or any other tender and reserves the right to accept the whole or part of the tender. Tenders will be opened in public as soon as practical after the closing time.

Tender documents can be obtained at a non-refundable tender fee as stated above from the Senqu Municipality Supply Chain Management Offices at the address stated above. Tender documents are available during office hours on Monday to Friday 08:00 – 15:30. Alternatively, documents will be available on the municipal the website <http://www.senqu.gov.za>.

A clarification meeting as stated above will be held on the date and time at the venue stated above.

**Tenders must be compliant with all bid requirements stated in the tender document.** Bidders are specifically referred to the requirements of the Preferential Procurement Regulations, 2017, including but not limited to pre-qualification criteria, functionality, eligibility, statutory, local content, compulsory sub-contracting, other objective, and price and preference criteria **as stated in the tender document.** If applicable, only locally produced, or manufactured goods meeting the stipulated minimum threshold for local production and content, will be considered. Tenderers' attention is drawn to the registration requirements in the tender documents in respect of registration on the municipal supplier database, Central Suppliers' Database, Construction Industry Development Board (if applicable), etc.

**Local content:**

- Only locally produced or locally manufactured wire and steel with a stipulated minimum threshold of 100% on local production and content will be considered.
- The exchange rate to be used for the calculation of local production and content must be the exchange rate published by the South African Reserve Bank (SARB) at 12:00 on the date of advertisement of the bid; and
- Only the South African Bureau of Standards (SABS) approved technical specification number SATS 1286: 2017 must be used to calculate local content.
