Tenders are hereby invited for the Construction of a new 132kV Eskom overhead line and switching station to supply the De Hoop Municipal substation in Malmesbury. The contract will be executed as a multiyear project.

Tenderers must be registered with the CIDB in an EP Class of construction works and have a grading designation equal to or higher than that determined in accordance with the sum tendered or a value determined in accordance with Regulation 25(1B) or 25(7A) of the Construction Industry Development Regulations, 2004. It is estimated that tenderers should have a CIDB contractor grading designation of **8EP or higher**.

Duly completed tenders in sealed envelopes marked "TENDER T06.25.26: CONSTRUCTION OF A NEW 132KV ESKOM OVERHEAD LINE AND SWITCHING STATION TO SUPPLY THE DE HOOP MUNICIPAL SUBSTATION IN MALMESBURY", together with the name and address of the Tenderer must be deposited in the tender box, Municipal Offices, Kerk Street, Malmesbury before 12:00 on Friday 17 October 2025, upon which the tenders will be made public.

A compulsory clarification meeting with representatives of the Employer will take place at the Municipal Offices of Swartland Municipality, PEP Building, at the corner of Hill and Piet Retief Street in Malmesbury on **Thursday 18 September 2025**, at 11:00. (Registration closes 11:05).

Bids will be evaluated in accordance with the Council's Preferential Procurement Policy (available on their website) and the attached specifications. Either the 80/20 or 90/10 preference point system will apply for the evaluation of the contract and that the lowest acceptable tender will be used to determine the applicable preference point system. Preference points will not be allocated if Annexure MBD 6.1, included in the tender documents, is not completed. Preference points MUST also be claimed in paragraph 6.1. Bidders are required to submit original and valid B-BBEE Status Level Verification Certificates or certified copies thereof together with their bids, to substantiate their B-BBEE rating claims. Bidders are also required to submit Proof of Locality in order to claim points for locality.
