Tender offers will be evaluated by an Evaluation Committee based on the technical and commercial risk criteria listed hereunder. 7.1 Technical risks:

Criterion 1: Experience on comparable projects during the past specify period between 5 and 10 years.

The tendering Service Provider's experience on comparable projects during the past specify period between 5 and 10 years. Aspects to be regarded as "comparable" includes (but may be extended according to circumstances): size of projects (measured against monetary value or other project quantifying parameters), nature of projects (building, engineering, high/low rise, etc.), locality/area of execution (site-specific influences, knowledge of local conditions, etc.), complexity of project, projects for similar client department irrespective of end purpose of buildings/facilities created or in progress of being created and time scales of projects (normal, fast track, etc.) and stage of its/their development.

4. Financial management: payment to suppliers and cash flow problems;
5. Quality of workmanship: extent of reworks and timeous attention to remedial works;
6. Personnel resources: suitably qualified and experienced, turnover in site staff and labour force, specifically site manager and foreman;
7. Personnel management: extent of labour disputes and ability to resolving labour disputes amicably;
8. Sub-contractors: extent of turnover in subcontractors, general liaison and payment problems experienced;
9. Contract administration: contractual aspects such as complying to laws and regulations, insurances, security, submission of required documentation timeously, reaction to written contract instructions, appointments of subcontractors, etc. as can generally be expected in standard/normal conditions of contract.
10. Health & Safety: adherence to regulations and compliance, and number of transgressions & serious incidents.

PA-10: GENERAL CONDITIONS OF CONTRACT (GCC)

NOTES:

The purpose of this document is to:

- (i) Draw special attention to certain general conditions applicable to government bids, contracts and orders; and
- (ii) To ensure that clients be familiar with regard to the rights and obligations of all parties involved in doing business with government.

In this document words in the singular also mean in the plural and vice versa and words in the masculine also mean in the feminine and neuter.

- The General Conditions of Contract will form part of all bid documents and may not be amended.
- Special Conditions of Contract (SCC) relevant to a specific bid should be compiled separately for every bid (if applicable) and will supplement the General Conditions of Contract. Whenever there is a conflict, the provisions in the SCC shall prevail.

General Conditions of Contract

1. Definitions

1. The following terms shall be interpreted as indicated:

- 1.1. **"Closing time"** means the date and hour specified in the bidding documents for the receipt of bids.
- 1.2. **"Contract"** means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
- 1.3. **"Contract price"** means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
- 1.4. **"Corrupt practice"** means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
- 1.5. **"Countervailing duties"** are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
- 1.6. **"Country of origin"** means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
- 1.7. **"Day"** means calendar day.
- 1.8. **"Delivery"** means delivery in compliance of the conditions of the contract or order.
- 1.9. **"Delivery ex stock"** means immediate delivery directly from stock actually on hand.
- 1.10. **"Delivery into consignees store or to his site"** means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
- 1.11. **"Dumping"** occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
- 1.12. **"Force majeure"** means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- 1.13. **"Fraudulent practice"** means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
- 1.14. **"GCC"** means the General Conditions of Contract.
- 1.15. **"Goods"** means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.

PA-10: General Conditions of Contract (GCC)

- 1.16. **“Imported content”** means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the supplies covered by the bid will be manufactured.
- 1.17. **“Local content”** means that portion of the bidding price which is not included in the imported content provided that local manufacture does take place.
- 1.18. **“Manufacture”** means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
- 1.19. **“Order”** means an official written order issued for the supply of goods or works or the rendering of a service.
- 1.20. **“Project site”** where applicable, means the place indicated in bidding documents.
- 1.21. **“Purchaser”** means the organization purchasing the goods.
- 1.22. **“Republic”** means the Republic of South Africa.
- 1.23. **“SCC”** means the Special Conditions of Contract.
- 1.24. **“Services”** means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such obligations of the supplier covered under the contract.
- 1.25. **“Written” or “in writing”** means handwritten in ink or any form of electronic or mechanical writing.

2. Application

- 2.1. These general conditions are applicable to all bids, contracts and orders including bids for functional and professional services, sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the bidding documents.
- 2.2. Where applicable, special conditions of contract are also laid down to cover specific supplies, services or works.
- 2.3. Where such special conditions of contract are in conflict with these general conditions, the special conditions shall apply.

3. General

- 3.1. Unless otherwise indicated in the bidding documents, the purchaser shall not be liable for any expense incurred in the preparation and submission of a bid. Where applicable a non-refundable fee for documents may be charged.
- 3.2. With certain exceptions, invitations to bid are only published in the Government Tender Bulletin. The Government Tender Bulletin may be obtained directly from the Government Printer, Private Bag X85, Pretoria 0001, or accessed electronically from www.treasury.gov.za

4. Standards

- 4.1. The goods supplied shall conform to the standards mentioned in the bidding documents and specifications.

5. Use of contract documents and information; inspection.

- 5.1. The supplier shall not, without the purchaser's prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the supplier in the performance of the contract. Disclosure to any such employed person shall be

made in confidence and shall extend only so far as may be necessary for purposes of such performance.

- 5.2. The supplier shall not, without the purchaser's prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.
- 5.3. Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the supplier's performance under the contract if so required by the purchaser.
- 5.4. The supplier shall permit the purchaser to inspect the supplier's records relating to the performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser.

6. Patent rights

- 6.1. The supplier shall indemnify the purchaser against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.

7. Performance security

- 7.1. Within thirty (30) days of receipt of the notification of contract award, the successful bidder shall furnish to the purchaser the performance security of the amount specified in SCC.
- 7.2. The proceeds of the performance security shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete his obligations under the contract.
- 7.3. The performance security shall be denominated in the currency of the contract, or in a freely convertible currency acceptable to the purchaser and shall be in one of the following forms:
 - (a) a bank guarantee or an irrevocable letter of credit issued by a reputable bank located in the purchaser's country or abroad, acceptable to the purchaser, in the form provided in the bidding documents or another form acceptable to the purchaser; or
 - (b) a cashier's or certified cheque
- 7.4. The performance security will be discharged by the purchaser and returned to the supplier not later than thirty (30) days following the date of completion of the supplier's performance obligations under the contract, including any warranty obligations, unless otherwise specified in SCC.

8. Inspections, tests and analyses

- 8.1. All pre-bidding testing will be for the account of the bidder.
- 8.2. If it is a bid condition that supplies to be produced or services to be rendered should at any stage during production or execution or on completion be subject to inspection, the premises of the bidder or contractor shall be open, at all reasonable hours, for inspection by a representative of the Department or an organization acting on behalf of the Department.
- 8.3. If there are no inspection requirements indicated in the bidding documents and no mention is made in the contract, but during the contract period it is decided that inspections shall be carried out, the purchaser shall itself make the necessary arrangements, including payment arrangements with the testing authority concerned.
- 8.4. If the inspections, tests and analyses referred to in clauses 8.2 and 8.3 show the supplies to be in accordance with the contract requirements, the cost of the inspections, tests and analyses shall be defrayed by the purchaser.
- 8.5. Where the supplies or services referred to in clauses 8.2 and 8.3 do not comply with the contract requirements, irrespective of whether such supplies or services are accepted or not, the cost in connection with these inspections, tests or analyses shall be defrayed by the supplier.

PA-10: General Conditions of Contract (GCC)

- 8.6. Supplies and services which are referred to in clauses 8.2 and 8.3 and which do not comply with the contract requirements may be rejected.
- 8.7. Any contract supplies may on or after delivery be inspected, tested or analyzed and may be rejected if found not to comply with the requirements of the contract. Such rejected supplies shall be held at the cost and risk of the supplier who shall, when called upon, remove them immediately at his own cost and forthwith substitute them with supplies which do comply with the requirements of the contract. Failing such removal the rejected supplies shall be returned at the suppliers cost and risk. Should the supplier fail to provide the substitute supplies forthwith, the purchaser may, without giving the supplier further opportunity to substitute the rejected supplies, purchase such supplies as may be necessary at the expense of the supplier.
- 8.8. The provisions of clauses 8.4 to 8.7 shall not prejudice the right of the purchaser to cancel the contract on account of a breach of the conditions thereof, or to act in terms of Clause 23 of GCC.

9. Packing

- 9.1. The supplier shall provide such packing of the goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage. Packing, case size and weights shall take into consideration, where appropriate, the remoteness of the goods' final destination and the absence of heavy handling facilities at all points in transit.
- 9.2. The packing, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the contract, including additional requirements, if any, specified in SCC, and in any subsequent instructions ordered by the purchaser.

10. Delivery and documents

- 10.1. Delivery of the goods shall be made by the supplier in accordance with the terms specified in the contract. The details of shipping and/or other documents to be furnished by the supplier are specified in SCC.
- 10.2. Documents to be submitted by the supplier are specified in SCC.

11. Insurance

- 11.1. The goods supplied under the contract shall be fully insured in a freely convertible currency against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the manner specified in the SCC.

12. Transportation

- 12.1. Should a price other than an all-inclusive delivered price be required, this shall be specified in the SCC.

13. Incidental services

- 13.1. The supplier may be required to provide any or all of the following services, including additional services, if any, specified in SCC:
- (a) performance or supervision of on-site assembly and/or commissioning of the supplied goods;
 - (b) furnishing of tools required for assembly and/or maintenance of the supplied goods;
 - (c) furnishing of a detailed operations and maintenance manual for each appropriate unit of the supplied goods;
 - (d) performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties, provided that this service shall not relieve the supplier of any warranty obligations under this contract; and

PA-10: General Conditions of Contract (GCC)

- (e) training of the purchaser's personnel, at the supplier's plant and/or on-site, in assembly, start-up, operation, maintenance, and/or repair of the supplied goods.

13.2. Prices charged by the supplier for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the supplier for similar services.

14. Spare parts

14.1. As specified in SCC, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier:

- (a) such spare parts as the purchaser may elect to purchase from the supplier, provided that this election shall not relieve the supplier of any warranty obligations under the contract; and
- (b) in the event of termination of production of the spare parts:

- (i) Advance notification to the purchaser of the pending termination, in sufficient time to permit the purchaser to procure needed requirements; and
- (ii) following such termination, furnishing at no cost to the purchaser, the blueprints, drawings, and specifications of the spare parts, if requested.

15. Warranty

15.1. The supplier warrants that the goods supplied under the contract are new, unused, of the most recent or current models, and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.

15.2. This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise in SCC.

15.3. The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.

15.4. Upon receipt of such notice, the supplier shall, within the period specified in SCC and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser.

15.5. If the supplier, having been notified, fails to remedy the defect(s) within the period specified in SCC, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.

16. Payment

16.1. The method and conditions of payment to be made to the supplier under this contract shall be specified in SCC.

16.2. The supplier shall furnish the purchaser with an invoice accompanied by a copy of the delivery note and upon fulfilment of other obligations stipulated in the contract.

16.3. Payments shall be made promptly by the purchaser, but in no case later than thirty (30) days after submission of an invoice or claim by the supplier.

16.4. Payment will be made in Rand unless otherwise stipulated in SCC.

17. Prices

PA-10: General Conditions of Contract (GCC)

- 17.1. Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the supplier in his bid, with the exception of any price adjustments authorized in SCC or in the purchaser's request for bid validity extension, as the case may be.

18. Contract amendments

- 18.1. No variation in or modification of the terms of the contract shall be made except by written amendment signed by the parties concerned.

19. Assignment

- 19.1. The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.

20. Subcontracts

- 20.1. The supplier shall notify the purchaser in writing of all subcontracts awarded under this contracts if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the supplier from any liability or obligation under the contract.

21. Delays in the supplier's performance

- 21.1. Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract.
- 21.2. If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.
- 21.3. No provision in a contract shall be deemed to prohibit the obtaining of supplies or services from a national department, provincial department, or a local authority.
- 21.4. The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the supplies are required, or the supplier's services are not readily available.
- 21.5. Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 21.2 without the application of penalties.
- 21.6. Upon any delay beyond the delivery period in the case of a supplies contract, the purchaser shall, without cancelling the contract, be entitled to purchase supplies of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.

22. Penalties

- 22.1. Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.

23. Termination for default

- 23.1. The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:

PA-10: General Conditions of Contract (GCC)

- (a) if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2;
- (b) if the Supplier fails to perform any other obligation(s) under the contract; or
- (c) if the supplier, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.

23.2. In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.

23.3 Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period of not exceeding 10 years.

23.4 If a purchaser intends imposing a restriction on a supplier or any person with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide why the envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated fourteen (14) days the purchaser may regard the intended penalty as not objected against and may impose it on the supplier.

23.5 Any restriction on any person by the Accounting Officer/ Authority will, at the discretion of the Accounting Officer/ Authority, also be applicable to any enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which the first-mentioned person, is or was in the opinion of the Accounting Officer/ Authority actively associated.

23.6 If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish The National Treasury, with the following information:

- i) The name and address of the supplier and/or person restricted by the purchaser;
- ii) The date of commencement of the restriction
- iii) The period of the restriction; and
- iv) The reasons for the restriction.

These details will be loaded in the National Treasury's central database of suppliers or persons prohibited from doing business with the public sector.

23.7 If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act No. 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Tender Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than ten years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.

24. Anti-dumping and countervailing duties and rights

24.1. When, after the date of bid, provisional payments are required, or antidumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. When, after the said date, such a provisional payment is no longer required or any such anti-dumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favourable difference shall on demand be paid forthwith by the contractor to the State or the State may deduct such amounts from moneys (if any) which may otherwise be due to the contractor in regard to supplies or services which he delivered or rendered, or is to deliver or render in terms of the contract or any other contract or any other amount which may be due to him.

25. Force Majeure

- 25.1. Notwithstanding the provisions of GCC Clauses 22 and 23, the supplier shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.
- 25.2. If a force majeure situation arises, the supplier shall promptly notify the purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the purchaser in writing, the supplier shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event.

26. Termination for insolvency

- 26.1. The purchaser may at any time terminate the contract by giving written notice to the supplier if the supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the supplier, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the purchaser.

27. Settlement of Disputes

- 27.1 If any dispute or difference of any kind whatsoever arises between the purchaser and the supplier in Connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.
- 27.2 If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the supplier may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party.
- 27.3 Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.
- 27.4 Mediation proceedings shall be conducted in accordance with the rules of the procedure specified in the SCC.
- 27.5 Notwithstanding any reference to mediation and/or court proceedings herein,
- (a) the parties shall continue to perform their respective obligations under contract unless they Otherwise agree; and
- (b) the purchaser shall pay the supplier any monies due the supplier.

28. Limitation of Liability

- 28.1 Except in cases of criminal negligence or willful misconduct, and in the case of infringement pursuant to Clause 6;
- (a) the supplier shall not be liable to the purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss 12 or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the supplier to pay penalties and/or damages to the purchaser; and
- (b) the aggregate liability of the supplier to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment.

29. Governing language

- 29.1. The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.

30. Applicable law

- 30.1. The contract shall be interpreted in accordance with South African laws, unless otherwise specified in SCC.

31. Notices

- 31.1. Every written acceptance of a bid shall be posted to the supplier concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice
- 31.2. The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.

32. Taxes and duties

- 32.1. A foreign supplier shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country.
- 32.2. A local supplier shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted goods to the purchaser.
- 32.3. No contract shall be concluded with any bidder whose tax matters are not in order. Prior to the award of a bid the Department must be in possession of a tax clearance certificate, submitted by the bidder. This certificate must be an original issued by the South African

33. National Industrial Participation Programme (NIPP)

- 33.1 The NIP Programme administered by the Department of Trade and Industry shall be applicable to all contracts that are subject to the NIP obligation.

34. Prohibition of Restrictive Practices

- 34.1 In terms of section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, an agreement between, or concerted practice by, firms, or a decision by an association of firms, is prohibited if it is between parties in a horizontal relationship and if a bidder (s) is / are or a contractor(s) was / were involved in collusive bidding (or bid rigging).

- 34.3 If a bidder(s) or contractor(s), has / have been found guilty by the Competition Commission of the restrictive practice referred to above, the purchaser may, in addition and without prejudice to any other remedy provided for, invalidate the bid(s) for such item(s) offered, and / or terminate the contract in whole or part, and / or restrict the bidder(s) or contractor(s) from conducting business with the public sector for a period not exceeding ten (10) years and / or claim damages from the bidder(s) or contractor(s) concerned.

1. PURPOSE

To provide firefighting equipment maintenance services for Department of Public Works and Infrastructure (DPWI) clientele across the Province of Mpumalanga for period of two years.

2. SCOPE OF WORK

The successful tenderer will be required to provide maintenance services and competent technicians. The fire equipment technicians will be expected to perform their duties of sprinkler system, fire detection, gas suppression, fire pump, fire hose reels, fire hydrants and portable fire equipment maintenance by servicing, monthly inspections of fire extinguishers, testing, pressure testing and installations **where needed**.

3. DETAILED SCOPE

The service provider shall provide the maintenance services to all fire fire-fighting equipment's. This will include the following:

- The monthly servicing where fire extinguishers are due, these will include fire extinguishers listed in the attached documents annexures. **Quantities and location of firefighting equipment attached.**
- The pressure testing of fire extinguishers and fire hydrants, installation, painting and refilling of firefighting equipment and the provision of parts when required.
- Where units are condemned or out for pressure testing or repairs, the service provider needs to mount replacement units' equivalent to the size and type **within one week**, consult with the DPWI concerning replacement units available at the store.
- The service provider needs to provide the original invoice for any spare used for replacement during the service with their mark-up price.
- The service provider shall provide the maintenance services to the fire hoses and hosereels, which will include: cleaning, pressure testing, patching and binding, yearly overhaul servicing, and yearly testing.
- The service provider will be requested at times to service fire extinguishers on an adhoc basis in the event that the pressure gauge is identified to be low or a fire extinguisher gets used for a fire.
- The service provider shall provide the maintenance services to the sprinkler system which will include: yearly overhaul servicing, yearly testing & servicing, as well as onrequest maintenance.
- The service provider shall provide the maintenance services to the fire detection, fire suppression system, fire alarm system, fire pumps and hydrants, foaming system, yearlyoverhaul servicing, yearly testing & servicing as well as on request maintenance and replacement of faulty parts. After maintenance, the service provider is required to provide a detailed report indicating defects and condition of the system. Replacement of parts or fixing of faults needs to be done within one month after maintenance and service has been conducted.
- Inspection of all fire equipment on a quarterly basis and providing a report to the DPWI representative. Inspection schedule must be created by the service provider and provided to the DPWI representative splitting the inspections into different sections to be covered over 3 months due to the size of the province and number of fire extinguishers. The service provider must provide personnel who will be conducting the quarterly inspections.
- The service provider is required to create a schedule for all fire equipment and indicate their maintenance intervals. When the equipment is due for service the service provider must make arrangements to go to cliental departments and conduct the servicingand provide sufficient man power for the job, not less than 2 Technicians to increase the turnaround time for maintenance.
- Upon completion of the maintenance and inspection, a report indicating defects identified must be provided to the DPWI Representative. Repairs of defects must commence within one month after maintenance has been conducted e.g. (pressure testing, fixing of damaged parts in fire extinguisher, fixing faults in fire detection systemetc.).
- On completion of the work on all the areas, the service provider shall bring the **signed job card** of the work done and the **compliance certificate** to the DPWI representative to certify that the work has been done according to the legal required standard.
- At the end of each month or work done the service provider shall make out a **detailed job card**, have it signed by cliental representative on site. A copy of the original job card with the tax invoice must be submitted to DPWI.

4. COMPLIANCE

The service provider shall ensure that all the statutory laws pertaining to but not limited to the handling of compressed cylinders, transportation of hazardous material, labour relations, occupational health & safety and national building regulations act are complied with.

The service provider must submit;

- The proof of company registration with ASIB for sprinklers, SAQCC Fire for fireextinguishers, fire detection and alarm as well as gas suppression.
- Health and safety legal appointments
- Valid letter of good standing as proof of registration to the Compensation Commissioner.
- Risk assessment for the work to be done.
- Proof that its personnel (technicians) have been trained and registered with SAQCC Fire.
- Proof of registration with SABS 1475 (must be the current certificate not the expiring one).
- Proof of registration with SANAS or the agreement to use the SANAS approved company.
- Any lifting equipment, ladders and scaffolding to be used for any of the works to be done isto have inspections logbooks and load test certificates.

The service provider shall at all times act professional while in the premises of DPWI and their client's premises.

5. TECHNICAL EVALUATION

Project Team members':

Project crew with valid certificates of competence in firefighting equipment maintenance.
Company organogram indicating the project team members.

Tools and Equipment:

All machinery (Electrical, mechanical tools) used for the maintenance of fire-fightingequipment to have valid certificates from approved authorities (SABS, etc.)

Years of experience, track record and value of contracts:

Years of experience of the service provider's personnel in conducting similar work with CV's and proof of experience in firefighting equipment maintenance for each individual.

Years of experience of the firefighting equipment inspector.

Three (3) written references from previous companies worked with similar work.

Quality Assurance Certificates:

- Certificate and written confirmation by the tenderer on how they will ensure that all aspects of the project are conducted in accordance with the best engineering, legal and environmental standards that will be used on this project, e.g. ASIB, SAQCC, SANAS and SABS 1475.
- Provide proof of previous quality control measures deployed in some or other projectscompleted by means of certificates or any other means.
- Proof of company registration with ASIB, SAQCC, SANAS and SABS 1475.
- Quality assurance plan and safety management systems employed by the company e.g.ISO, SANS, etc.

Risk Analysis and Mitigating Measures:

Identification of risks that are associated with testing and inspecting firefighting equipment

A clear mandate on mitigating measures in place for all identified risks associated with thehandling of firefighting equipment.

SHE File Requirements

Below are some of the documents that make up a SHE file which will be submitted upon award:

- Risk Assessment and Control measures for the specific activities to be performed
- Fall Protection Plan
- Letter of Good Standing with Compensation Commissioner
- List of PPE to be used
- Registers – vehicles/machinery/tools/Safety Talks
- Team members' medical certificates for the current financial year.
- Copies of Contractor SOP's / Work Instructions
- If Hot work to be done: Competence certificates for persons performing Hot Work
- List of equipment / tools with valid log sheets.

Before awarding a service provider is expected to submit a provisional SHE file DPWI representative for approval.

6. GENERAL

- Working hours will be allowed from 08h00 to 16h00 (Monday to Friday), the successful service provider based on the amount of work and resources must determine their own working hours needed to ensure all work complete.
- All Scaffolding shall be erected by qualified, certified erectors and inspection certificate to be provided.
- Service provider shall practice good "housekeeping" and leave the site clean and tidy.
- When vacating the area the contractor will remove equipment and debris from site. Anything damaged by the service provider will be the responsibility of the contractor to repair that area at their own cost.
- Electrical power point will be provided.
- All work to be carried out must adhere to OHS Act

7. SAFETY RELATED ITEMS

- Safety of all electrical tools shall be checked and certified as per statutory requirement and certificates.
- Tenderer to provide inspection certificates of all lifting gear, equipment, scaffolding and rigging equipment as per statutory requirement and certificates must be submitted with the tender Document.
- As part of the safety file a comprehensive risk assessment and method statement must be included for approval.
- All workers must be qualified for their specific work- proof of qualification must be included in safety file
- The service provider must ensure that all its personnel have all the necessary protective clothing whilst within and working in DPWI clients sites.
- The service provider must ensure that all the necessary fire protection and a qualified firefighter will be on site whilst carrying out such work.

8. SCHEDULING OF THE WORKS:

The tenderer with his first-hand knowledge of contracts of this nature, his own capabilities and the current activity in the engineering is to give a schedule time for execution of the works; and

Tenderers must note that other parts of sites will be operational during the execution of the works; and

The successful service provider would be required to schedule his site work such that it does not interfere with the daily operations or there is minimal disturbance to operation.

9. PERFORMANCE SPECIFICATION (SCORE CARD)

GENERAL

The Contractors performance will be measured against the following four parameters.

- Minimum incidence of faults
- Minimum downtime
- Good record keeping
- Optimal service costs

Operational efficiency will be evaluated against the standards set out above. The statistics will be recorded and set out in the quarterly report submitted to the Department by the Contractor.

AVAILABILITY OF SYSTEMS

Any machine or system will in general be regarded as available when the system is performing the duty for which it originally was designed. When any component is “out of operation” this shall mean any component not working at all as well as when the component is still working but when the performance of the component cannot meet the design duties as originally specified.

PERFORMANCE STANDARD

The contractor shall restore each system as detailed in this specification and maintain it to ensure the successful operation thereof. For this purpose the minimum requirements shall be measured against availability of the overall system of 90% or better. This availability will be calculated as follows.

$$\text{Availability} = \frac{(T_i - T_{di})}{T_i} \times 100$$

Where:

T_i - The length of the time interval i for the applicable month under consideration expressed in hours

T_{di} - The total of the MTTR's for the individual system during the time interval i for the applicable month under consideration expressed in hours

MTTR- This mean the time to repair the system as determined from the fault/service/repair logbook, and shall be equivalent to the sum of all the times that the system or any part of the system, does not conform to the operational requirements.

EXAMPLE CALCULATION

4.1 April has 30 days @ 24 hour operation per day, this makes T_i 720 hours

4.2 During the month 3 breakdowns, each with a response time of 1 hour and a repair time of 5 hours. The scheduled service takes 20 hours.

In this example

MTTR1 $3 \times (1+5) = 18$ hours and MTTR2 = 20

Sum of MTTR's $18 + 20$ giving $T_{di} = 38$ hours

$$\begin{aligned} 4.3 \quad \text{Availability} & \quad \frac{(720-38)}{720} \times 100 \\ & = 94,72\% \end{aligned}$$

The onus shall rest on the contractor to submit the necessary motivation to the Department for its consideration and decision for MTTR periods, which the contractor considers to have been caused by factors outside his control, and which should not be included in the calculations, e.g. malicious damage, lightning, import of material, etc. Actual damaged or faulty equipment shall be presented by the contractor as proof before removal thereof or repairs thereto.

Where breakages or faults are caused by factors outside the contractor's control, he shall immediately report the incident to the Department in writing, giving a full list of the details/persons involved. A specified quotation must be attached to the report including and showing mark up. If prices are unreasonably high, the Department reserves the right to pay the contractor an amount in line with current market related prices only, plus mark up.

GUARANTEE OF PERMORMANCE

The contractor shall guarantee the availability of 90% of all systems specified in this contract, as calculated and specified in paragraph 4 hereof. In the event of the contractor failing to achieve this specified availability, a penalty, equal to ten cents per One Hundred Rand of the total contract value will be levied against the contractor for each percentage point per month that the overall system availability is below the availability percentage as specified herein. The penalty will be levied each month during which the availability is below the specified percentage, and not on an annual or contract period basis.

CONDITIONS AND CIRCUMSTANCES EXCLUDED FROM THE AVAILABILITY CONCEPT

In cases where spares have to be import or specially manufactured. In all these cases the fact must be proofed and estimated time needed to obtain the spares must be given.

SERVICE SHEETS

Every service, repair, test etc., shall be fully described on a work sheet which must be completed on site and signed by the Department. The following minimum information shall appear on work sheets:

- The company name and address
- A work sheet serial number
- The building name
- The system number and system description
- The call-out no. (if applicable)
- The nature of the call, i.e. urgent or normal call-out
- A general description of the problem or purpose of the work done
 - A statement whether the individual system is in terms of the specification operational or not
 - Should the system not be operational the response time and repair time shall be recorded individually
 - The ID number, machine/equipment description and description of the repairs/replacements carried out on each machine/equipment item on that specific system
- A list of material used for each machine/component
 - A detailed report on the extent of the work done together with the estimated cost involved

- Suggestions to avoid future problems
 - A list of the Contractor's personnel responsible for the work with the date, starting time, completion time and distance travelled
- Signature and name of the responsible technician/artisan/engineer
- Signature of the Department of Infrastructure Development Representative

Service sheets shall also be used for normal routine maintenance services.

SITE MAINTENANCE FILES AND SHELVES

The contractor shall provide and maintain hard cover A4 maintenance files for each site, which shall be kept in the client file. These logbooks will remain the property of the Department and may not be removed from the client offices under any circumstances. The contractor shall be required to file all master copies of the Service Reports for each system in chronological order.

10. REPAIR AND RESPONSE TIME

It shall be expected of the Contractor to relate his actions in respect of call-outs, repairs and general maintenance to specific prescribed response and repair times.

Depending on the urgency of the call-out, the response times may vary and the table below indicates maximum time-spans.

CALL-OUT TYPE	RESPONSE TIME	REPAIR TIME
Emergency	1 hours	Refer Definition below
Normal	4 hours	

where:

RESPONSE TIME shall mean the time lapsed from the time the call-outs are logged by the system operator or person making the call. Until the Contractor responds on site. The time shall be recorded in the Service Sheet if the system is not operational as specified in terms of this specification.

REPAIR TIME shall mean the maximum time taken by the Contractor to repair the fault, in order to limit the downtime of the system to a minimum. The time shall be recorded in the Service Sheet if the system is not operational as specified in terms of this specification.

Unless for circumstances beyond the control of the contractor the down-time on systems shall be limited to the following:

48 hours for completion irrespective of the breakdown

DOWNTIME with respect to call-outs, shall mean the total time for which the system is not 100% operational, i.e. response time plus repair time.

With regard to Routine periodic services, the Contractor shall notify in writing the Department Representative and the institution at least 7 days in advance.

11. INSPECTION AND TESTING

The Department and/or its duly appointed representative, or any person he may appoint for any purpose, may inspect and test the various portions of the work at all times and shall have full power to reject all or any portion of the work that he may consider to be defective or inferior in quality of material, workmanship or design with respect to the original installation. Any portion of the work so rejected shall be replaced immediately by the Contractor, unless, in the opinion of the Department, the work rejected can be so treated and repaired as to render it fit for incorporation in the contract works. In this event the Contractor shall, at his own risk and expense, be at liberty to repair the work to the satisfaction of the Department. The Contractor shall carry out such tests as are necessary, in the opinion of the Department, to prove that the contract requirements are being complied with.

The cost of all tests and/or analyses shall be borne by the Contractor.

12. SITE MEETING

A meeting between the Department and/or its duly appointed representative, and the Contractor shall be held monthly or more frequently if so required by the Department, at a time, date and venue determined by the Department, to discuss all aspects of the maintenance of works as documented in the Quarterly Report. No additional compensation will be paid for this.

The site meetings will be under the chairmanship of the Department Representative and/or his duly appointed representative.

13. SHUT DOWN OF EQUIPMENT AND PLANT

No mechanical/electrical equipment or plant involved in this Contract may be shut down, switched off or isolated in any way without prior written permission from the Head of the Institution concerned, being a Superintendent or the most Senior Personnel of the facility/Institution at the time of the request.

Maintenance and repairs shall be carried out timorously, punctually and with the utmost care to minimize the necessity for affecting the services rendered by the installation/equipment covered by this Tender/Contract. Should during the effecting of any repair, it be deemed necessary to isolate any section of the plant arrangements shall be made with the Representative of the Department who will make arrangements with the official in charge of the sections of the institution served, which will be affected by the intended shut-down, prior to proceeding with the intended activities.

The request for a shutdown shall be channelled in the following manner. The Contractor must first approach the Department Representative, so as to assess that the shutdown is necessary. The representative will approach the Institution/Facility's authorities for authorization of the shutdown. In the event of any emergency, and a Representative of the Department is not available at the time, the Contractor shall get authority from the Superiors of the Institution or Facility concerned and shall thereafter furnish the Representative of the Department with a copy of such written authorization for record purposes.

14. REPLACEMENT PARTS AND MATERIAL PROVIDED FOR IN THE PARTS AND MATERIAL PRICE SCHEDULE

Authorization for the replacement of parts or materials shall, when such replacement is required, be obtained from the Representative of the Department, before such replacement is executed, subject to the limits set out below.

If replacement of parts or material are necessary for items not covered in the schedule the contractor must submit a written quote to the department representative.

The Contract has two phases, a repair phase and a maintenance phase.

Some differences between the phases are noted in the table below:

Installations are to be repaired to a fully serviceable condition if necessary, before any maintenance can commence. Hence the following categories:

15. MAINTENANCE TYPES

Maintenance refers to a routine and/or remedial intervention required, ensuring that the asset is retained in a serviceable condition, and also to ensure that it retains its value and usefulness.

There are different kinds of maintenance services that are to be undertaken, depending on the installation to be maintained, namely: -

Preventative Service Maintenance – for which the service provider has to perform certain actions to prevent failure on the operation of the installation in due course.

Condition-based Maintenance – it is corrective maintenance to be performed to restore the installation to its required condition or standard.

Statutory Maintenance – both preventative and condition-based maintenance may contain the elements of statutory maintenance which is defined in the Act as actions performed to meet legal requirements as contained in the Occupational Health and Safety Act No 85 of 1993 and other relevant regulations.

Emergency Maintenance – these are reactive maintenance actions performed to restore installations to operational condition.

Incident Maintenance – actions performed to restore an installation to an operational or safe condition after it was damaged as a result of external events.

The Contractor shall compile the Preventative Service Maintenance Works Programme for periods of three months and submit same in writing in advance to the Representative of the Department, giving him/her enough time to evaluate and to notify the Contractor of possible amendments before approval.

The contractor shall compile a condition-based Maintenance programme based on the results of machinery inspections

16. REDUNDANT MATERIAL

The Contractor shall hand over all used parts (worn and/or damaged) to the Representative of the Department as such become the property of the Department and shall be handed to the Representative of Department or client Representative.

17. INSTRUCTIONS TO CONTRACTOR

No instructions from any personnel other than the Department Project Manager or Lead Project Manager shall be carried out.

The Department will ensure that a **logbook/job card** is kept on Site and that all faults and defects reported after hours are recorded. A report for each call-out will be entered by the Contractor's Supervisor in this book and signed by the client Representative and the Project Manager employed by the Department.

The nature of work at the Institutions is such that all repairs will be carried out punctually, with great care and minimal inconvenience to the facility.
