REQUEST FOR QUOTATION FOR THE REPAIR OF AUTOMATED FLY BARS The purpose of this request for quotation is to appoint a service provider to repair two fly bars in the Opera House. Background Artscape is a facilitator of stage performances and has three performance venues including the Opera House. The Opera stage has a permanently installed automated / computerized flying system which comprises 69 fly bars and control equipment for these fly bars which are primarily used for flown scenery and to suspend lighting and sound equipment in productions. The fly bars were upgraded between 2003 and 2012 and are all be able to run in any of the synchronous operating modes from the new control desk. Each upgraded fly bar has a new 3-phase squirrel cage motor and gearbox and new variable speed ac drive, new small PLC in the drive panel for all local control functions and computerised closed loop position control from the main computer (A250). The mechanical system that drives the batten height indicator from the counterweight is retained and adapted to drive a new position encoder to give the exact batten height to the computer. A new digital encoder on the motor feeds its exact speed back to the digital drive, so speed control is very accurate and consistent in both directions from zero up to full speed with any load on the bar up to the full rated load. These hoists can also be driven either from the new control desk or from the existing local height indicator console on the fly floor. Maximum speed is increased to 1800 mm/sec for computer operation but is slower for local control from the height indicator. Two of the fly bars, bar 8 and 9, are currently not working. We consider the main problem to be the encoders fitted to these winch driven fly bars. Scope of works • Assess the fault and make recommendation accordingly • Supply deliver and install parts and components required	

- Provide 24 months warranty and guarantee on parts from date of installation.

CERTIFICATE OF INDEPENDENT BID DETERMINATION
