1. SCOPE

2. INFORMATION REQUIRED

- 2.1. Tenders shall provide enough details at the tendering stage to enable the Transnet Technical Officers the opportunity to assess each offer properly.
- 2.2. Tenders shall complete the relevant questionnaire in full and must indicate whether their offer complies with each item of the specification.
- 2.3. Should there be insufficient space for providing full details, bidders shall provide the additional details in their covering letter. The additional details shall be numbered in accordance with the applicable clause specified in the specification.

3. GENERAL REQUIREMENT

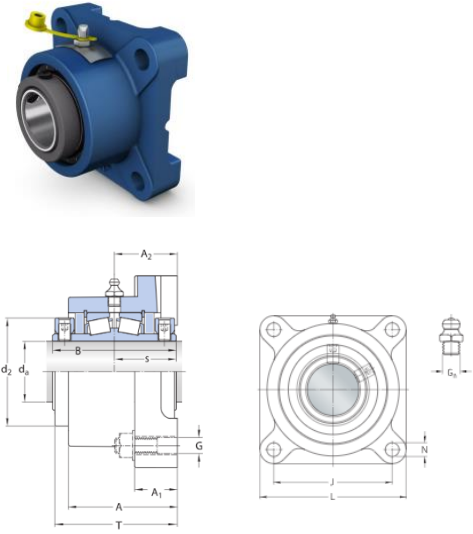
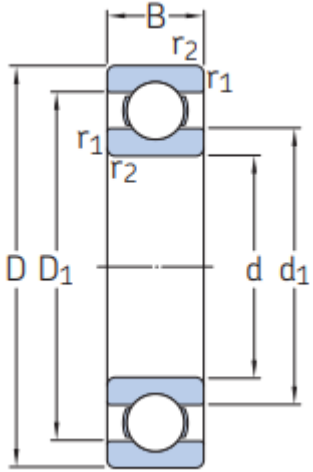
