## SECTION 4

### SCOPE AND SPECIFICATION

#### **1. PROJECT PURPOSE**

The purpose of this project is to acquire a contractor to supply of signage boards (supply and install the height gauges at level crossing) in various location, KZN region as indicated on the bill of quantities.

#### **2. GENERAL**

- 2.1. The contractor shall be responsible for dismantling the old and existing height gauges in various locations.
- 2.2. The contractor shall supply and install concrete foundations.
- 2.3. The contractor shall supply and install 64kN, 10m concrete mast pole as per BOQ.
- 2.4. The contractor shall supply and install height gauge warning signs as per BOQ.
- 2.5. The contractor shall supply and install the anchored galvanised steel stay wire complete set with accessories
- 2.6. The contractor shall be supply and install aluminium power cable wire clearance between 5.1m and 4.7m.
- 2.7. PRASA reserves the right to inspect and or test any material or equipment during the installation process.
- 2.8. The contractor shall be responsible for all machinery and equipment require to the successful completion of work.
- 2.9. The contractor shall undertake work on the rectification of any defects or damages occurred to OHTE infrastructure that may arise during the demolishing within 7 days of him being notified by Metrorail of such defects.
- 2.10 Safety and supervision (Provided by the contractor)
- 2.11 The successful contractor shall prepare and submit a safety file.
- 2.12 On site work, shall not commence unless the contractor's responsible person has acknowledged the conditions contained in the electrical work permit by way of signing the work permit form.
- 2.13 The contractor shall not proceed with work before having properly informed and warned all his staff of potential dangers of adjacent live equipment pointed out to him by the PRASA electrical officer who issues and controls the work permit.
- 2.14 The contractor shall provide his own protection.

#### **3. ADDITIONAL WORKS**

Any additional work not authorized by the regional electrical engineer, even if proven necessary for the successful completion of the project will be tenderer's own account.

#### 4. DESCRIPTION OF WORK

The contractor shall perform the following task according to BOQ:

- 4.1 Supply and installation concrete mast foundation.
- 4.2 Supply and installation of 64kN, 10m mast pole
- 4.3 Supply and installation of aluminium height gauge warning sign with associated accessories.
- 4.4 Supply and installation of 75mm aluminium wire for height restriction, with crossby, eye bolts, thimbles and associated accessories
- 4.5 Supply and installation of galvanised anchored stay wire complete set with associated accessories
- 4.6 Transport old structures to PRASA Clairwood depot

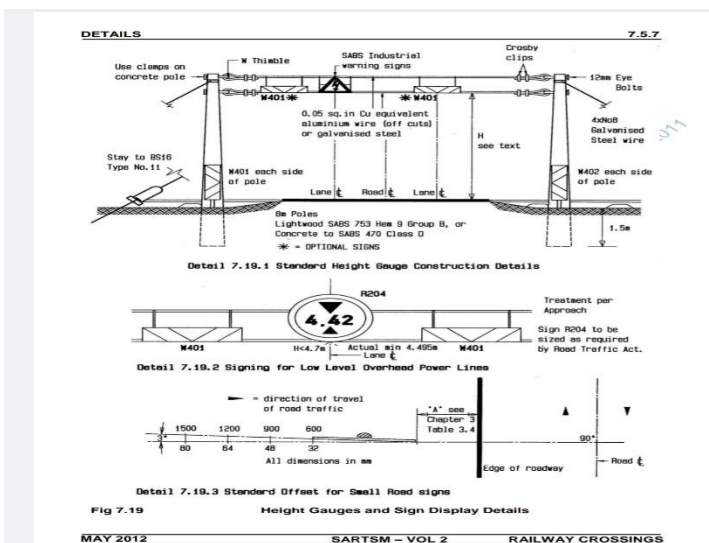


Fig 1: Height Gauge

#### 5. TECHNICAL DETAILS

- 5.1 Dismantle the old height gauges at level crossings in various locations.
- 5.2 supply and install concrete mast foundation
- 5.3 supply and install 64kN, 10m concrete mast pole
- 5.4 Supply and install 75mm aluminium wire for height restriction with crossby, thimbles, eye bolts and associated accessories (**SANS 3000-2-2-1:2012**)
- 5.5 supply and install height gauge warning signs complete set with associated accessories (**SANS 3000-2-2-1:2012**)
- 5.6 Supply and install anchored galvanised steel stay wire complete set with associated accessories. (**SANS 3000-2-2-1:2012**)

#### 6. Duration

- 6.1 The overall duration of the work shall be **six (6)** months including the payment process.
- 6.2 Work shall commence immediately from date of award.



## **7. PENALTIES**

- 7.1. If the contractor fails to complete the Works to the extent which entitles him to receive a Certificate of the Practical Completion in terms of Clause 23.10.2 as per the GCC, by the due completion date, the Contractor shall be liable to the Employer for an amount calculated 0.3% of the Contract Price per delayed day, which shall be paid for every day which shall elapse between the Time for Completion and the date stated in the Taking-Over certificate. However, the total amount due under this Sub-Clause shall not exceed the maximum of 10% of the Contract Price. (Clause 23.9 as per GCC is applicable).
- 7.2. The contractor will be charged R10 000 for working on Metrorail site without proper site access or working without an occupation.
- 7.3. The contractor will be charged a penalty of R80.00 per minute per train that was delayed
- 7.4. The contractor will be charged the penalty of R 1 500.00 per train that was cancelled.

## **8. CLEARING OF SITE**

All rubble which is left over as a direct result of work performed by the contractor shall be removed from site and be transported to PRASA Clairwood Electrical depot.

#### **Delivery and documents**
