# 1. PROJECT INFORMATION

#### 1.1. Purpose of RFQ

The JDA is requesting quotations from experienced professional consultants in mechanical (fire and wet services) and structural engineering to prepare concepts, detailed designs and technical documentation for the Frank Brown Park Social Housing project situated in Milpark, in the City of Johannesburg for a period not exceeding 12 months.

#### 1.2. Introduction

The JDA is completing the Frank Brown Park Social Housing project on behalf of the JDA, the project entails the completion of a feasibility study, designs, and technical documentation for the implementation of the project. In 2019 a feasibility study was conducted for the Milpark Social Housing Project on Remainder of Portion 55 of the Farm Braamfontein 53-I.Q, identified as a possible site for social housing in the Milpark UDF. The purpose of the feasibility study was to determine whether it would be possible develop social housing on the property. The study included Feasibility Reports with an analysis and recommendations on probable town planning, structural, infrastructural, scheme with potential yield implications. The study also included the completion of preliminary concept designs based on the identified potential yield.

A team of professional consultants was appointed in August 2023 that consists of a Town Planner, Architects, Property Economist, Geologist, Land Surveyor, Quantity Surveyor, Traffic Engineer, Civil Engineer, Electrical Engineer, Conveyancer, and Environmental and Heritage Specialists. The professional team has completed the feasibility study and commenced with the concepts and detailed designs.

# 1.3. Project Objective

The objective of the RFQ is to appoint a mechanical engineer and structural engineer to assist with the development of concepts detailed designs, and technical documentation along with the appointed professional team.

#### 1.4. Project Location

The project is situated on Erf RE/55/53-IR Farm, it is along Napier Road and Barry Hertzog Avenue in Milpark, Region B of the City of Johannesburg. The study area for the precinct area is depicted in Figure 1 below.

# 2. SCOPE OF SERVICES

The JDA intends to appoint a competent consultancy to complete concept, detailed design and technical documentation for the development of social housing in Frank Brown Park, Milpark. The scope of work entails providing technical expertise in:

# **2.1.** Appointment

# **2.1.1.** Structural Engineer

The Structural Engineer will be required to be registered as a Professional Engineer with the Engineering Council of South Africa (ECSA) and have the relevant skills, experience, and capacity to deliver the following scope of work within the required time frame which entails but not limited to:

- Concept, detail and construction document preparation
- Assess and determine required structural requirements and services for the building to meet anticipated densities

# 2.1.2. Mechanical Engineer

The Mechanical Engineer will be required to be registered as a Professional Engineer with the Engineering Council of South Africa (ECSA) and have the relevant skills, experience, and capacity to deliver the following scope of work within the required time frame which entails but not limited to:

- Comment on natural ventilation compliance;
- Investigate implementing prepaid water;
- Determine if the expected demand for sewer drainage and potable water to ascertain if existing services and supply will be sufficient.
- Comment on required number of staircases and if stairs on current design is sufficient.
- Allocate best position for assembly area in case of fire
- Indicate FHR, FH etc
- Advise on heat and smoke detection device requirements
- Advise on Smoke control requirements
- Calculate the expected demand for fire water to ascertain if existing supply will be sufficient

# 2.2. Project scope in stages

All other drawings prepared using AutoCAD, MicroStation or any other drawing software shall be submitted in a compatible format that can be open or converted to DWG, DXF and DGN format.

The deliverables will need to include very high-quality visual products that can be used as marketing and promotion tools to encourage and promote buy-in to the proposals and business cases, and will include PowerPoint Presentation materials for workshopping / meeting / stakeholder engagement purposes.

Contactable references: References must be for COMPLETED projects only. References must be on the client's letterhead or on a document with the client's company stamp and signed by the client. The letter / document <u>must</u>

#### 5.1 Compliance

Bidders will be disqualified in the following instances:

- In the case of a bidder who during the last five years has failed to perform satisfactorily on previous contracts with the JDA or any other organ of state after written notice was given to that bidder that performance was unsatisfactory;
- Bidders who did not complete, in full, the tender offer page (i.e. priced, all registration numbers provided and signed);
- Bidders whose tender document has been completed in pencil;
- > Bidders whose document has been faxed;
- > Bidders whose tender document has been received after the closing time;
- > Bidders whose tender document has not been deposited in the tender box at the time of closing;
- ➤ Bidders who fail to price as required i.e., as stipulated in item 3 and 6.1 herein;
- > Bidders who have any directors in the employment of the state;
- > No award will be made to any bidder whose tax matters are not in order with the receiver of revenue (SARS);
- No award will be made to any bidder who is not registered on the National Treasury Central Supplier Database (CSD);

Tenderers will have to adhere to the compliance items above in order to be considered further in the evaluation process.

#### 5.2 Technical

The technical assessment is based on the criteria set out below namely (i) key returnable documents, (ii) capability of the proposed key team members (i.e. experience, qualifications, and memberships to professional associations per Item 4.15 above) and (iii) the experience of the company (i.e. housing strategies, plans and/ or feasibility studies), and references per Item 4.16 above).

- 5.3.1.1 "B-BBEE status level of contributor" means the B-BBEE status received by a measured entity based on its overall performance using the relevant scorecard contained in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act ( Act No.53 of 2003).

#### 5.4 Risk Tolerance

The JDA has adopted a Risk Tolerance Framework (RTF) which enjoins the JDA to consider its risk exposure to contractors / service providers in terms of the number of contracts awarded to a single contractor / service provider in a particular year. In terms of the Risk Tolerance Framework, the JDA determines the risk exposure as excessive in instances where the value of the contracts for individual professional service providers (eg. project managers / engineers / quantity surveyors / consultants) is either:

The greater of R8 million or four contracts / projects in the current financial year or The greater of R12 million or six contracts / projects over two financial years (current year and previous financial year)

And in instances where the value of contracts for multi-disciplinary professional service providers (eg. more than one discipline / service is provided by the same bidder) is either:

The greater of R12 million or six contracts / projects in the current financial year or
The greater of R20 million or nine contracts / projects over two financial years (current year and previous financial year)

A risk analysis shall be undertaken on the bidder with the highest number of points obtained, to determine whether the tenderer does not exceed the JDA's risk framework criteria as stated above. In other words, whether it falls within the ambit of the Risk Tolerance Framework as acceptable.

JDA reserves the right to award a contract to a bidder who has exceeded the threshold as stated above.
