1. Manufacturing Process

Use 5558-6110-B COIL ASSEMBLY.pdf, Annexure B as reference.

Coils are wound with enamel insulated copper wire to form a Litz wire, specified as item 1 in table 1.

Copper wire strands are required to be manufactured by twisting together 10 strands of enamel insulated \emptyset 0.75 mm copper wires.

10 Cu core Twisting pitch = 30 mm

 $\emptyset_{\text{effective}}$ of 10 core twisted strands = 3.4 mm

A sample piece will be supplied as reference. iThemba Labs technical staff require to be present to approve the initial formed litz wire.

Furthermore, based on Ø 3.6mm.

There are 18 vertical windings per layer separated, spaced and held into place with insulating 5558-6112-B – COIL SPACERs between each turn (winding in vertical direction).

The 10-core strand will have a vertical centre spacing of \pm 4.0 mm.


This will be repeated to form 10 horizontal layers spaced at 3 mm centre distance apart to ensure and allow forced air passing and circulating through the windings.

There is a total of 180 turns per coil, with a length of ~1 m cord length per turn which add up to 180m in total. 5558-6112-B – COIL SPACER to be strategically placed to avoid contact between twisted lead spiral strands and maintain tension where required

2. Quantity and Testing

A total of four (4) fully assembled coils is required.

Tests must be conducted to assure assembly & function according to Annexure C – 5558-6110-A-Quality Assurance, to assure the completed assembly conforms to the function and dimensions indicated in drawing Annexure B, 5558-6110-B COIL ASSEMBLY.pdf.
