## PREFERENCE POINTS CLAIM FORM IN TERMS OF THE PREFERENTIAL PROCUREMENT REGULATIONS 2022

1.1 The following preference point systems are applicable to invitations to tender:

1.2 **To be completed by the organ of state**

1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

## 2. DEFINITIONS

- (a) **"tender"** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **"price"** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **"rand value"** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **"tender for income-generating contracts"** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **"the Act"** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

#### 4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

**1. PURPOSE**

To conduct comprehensive health screening i.e. Prostate (finger prick) and Pap smear screening services for employees onsite.

**2. SCOPE OF WORK AND DELIVERABLES**

**The service provider is expected to provide the below:**

- Onsite Prostate (finger prick) and Pap smear screening services for Head Office employees;
- All necessary screening equipment such as examination bed, examination light for screening purposes;
- Individual prostate and Pap smear results and feedback after screening, to employees who participated in the screening (telephonically/virtually).
- Organizational feedback report emanating from screening results including but not limited to number of participants , outcome of screening, recommendations etc. (No confidential client information is required).

**3. PRICING**

#### 4. KNOWLEDGE AND EXPERIENCE

- The Bidder (the Company) to have at least three (03) years of experience in the provision of medical services. **Reference letter indicating the nature and duration of the services rendered should be attached to the quotation/proposal**
- Bidders are required to submit a declaration letter confirming the use of qualified and registered staff with three (3) or more years of experience as Medical professionals. **(Annexure B).**
- Professionals rendering the cancer screening must be registered with HPCSA or SANC - **Proof of registration with HPCSA or SANC should be attached to the quotation/proposal.**
- The Service Provider to have capacity to render the cancer screening services to up to 50 employees in a day 08h00-16h00 i.e. **confirm availability of at least 2 registered Medical professionals to render the requested service.**

**NB:** SASSA will provide facilities (private rooms) for screening and consultation on the day.
