## SPECIFICATIONS OF GOODS REQUIRED

### 1. BACKGROUND

uMngeni- uThukela Water intends to procure specialized mechanical EPDM seals for repairs to joints of pre-stressed concrete pipes on the 53 Pipeline. The EPDM seals are a critical spare and have to be available when failures occur.

The 53 Pipeline is a **pre-stressed** concrete pipeline conveying portable water from DVH Harris to the 45 MI reservoir at uMlaas road. The 53 Pipeline is critical in supplementing supply to UMaas road reservoir in order to have sustainable supply to meet the demands at this node.

### 2. DESCRIPTION OF GOODS/ SERVICES REQUIRED

The scope of work is for EPDM seal

- Supply of 686 mm diameter/±2115 mm circumference EPDM seals.
- Supply of 762 mm diameter/±2355 mm circumference EPDM seals.
- Supply of stainless steel keeper rings for the 686 mm
- Supply of stainless steel keeper rings for the 762 mm
- Supply of hydraulic jacks (Enerpac RC104 or similar approved)

### 3. EXTENT OF THE SERVICE

Delivery to Mkondeni Workshop

### 4. TECHNICAL SPECIFICATIONS

#### TIME FOR COMPLETION

The time allowed for the completion of any work must be abided to the time frames reflected (1 months = 4 weeks) from the date of placing the order.

#### SPECIFICATIONS OF THE MECHANICAL SEALS SCOPE

The Type 1 mechanical seals specified in this specification shall generally be used for the **internal sealing** of spigot and socket joints, of various types, that are no longer performing their intended function.

When used in conjunction with internal sleeves, the mechanical seals can be used to remedy or replace defective / failed pipes as for Type 2 and Type 3 respectively of this specification. This specification covers the supply and installation of mechanical seals for the **internal sealing** of pipe joints of 686 ID and 762ID .

### DESIGN & PERFORMANCE

The mechanical seal shall comprise a continuous resilient EPDM rubber seal (minimum thickness = 4mm) maintained in position with two (2) stainless steel keeper rings that shall compress the seal to the inner pipe bore. A single keeper ring shall be fitted on either side of the pipe joint.

The design of the EPDM seal shall be formed in such a manner that increased pipe internal pressure tends to enhance the hydraulic seal.

The seal shall be capable of resisting an internal (positive) pressure of 20 bar and a negative pressure of 0.5 bar.

The keeper rings shall be of robust construction and shall be fabricated and stiffened in such a manner that they resist buckling when compression forces are applied to compress the EPDM seals into position. The design of the keeper ring shall ensure that it can be welded or bolted to retain the EPDM seal in the compressed position without causing welding damage to the EPDM seal.

The supplier may be required to furnish the Engineer with his design calculations.

### MATERIALS

#### General

All materials shall be new and shall comply with SANS standards.

All materials shall be suitable for use on potable water applications and shall be subject to the approval of the Engineer.

The Contractor will be required to submit full particulars of all materials with his offer.

#### EPDM Seals

The EPDM seals shall be extruded from virgin material.

The seal shall have a minimum width of 200mm and it shall have at least four tongues, formed and located to enhance the seals sealing capability with increased internal pressure.

The pipe diameter shall be accurately determined and the seal vulcanized to form a continuous circular seal that shall snugly fit the joint accurately without the seal being in tension or suffering from buckling due to it being too large.

The vulcanized joint shall be free of defects and have a tensile strength equal to the parent material.

#### Keeper Rings

The keeper rings shall be fabricated from 304 stainless steel. All sharp edges and burrs shall be removed from the keeper rings. All factory and in-situ welds shall be pickled and passivated upon completion.

The stainless steel keeper rings shall be designed by the Contractor to ensure that they perform their intended function and do not buckle due to any unbalanced forces, dynamic loading or

minor imperfections in pipe roundness. In this regard the Contractor shall assume that pipes may be up to 4% (on diameter) out of round.

The keeper rings shall have a minimum bearing width of 40mm. It shall be designed so that it may be compressed using hydraulic or mechanical means and once compressed in position; it shall be possible to weld the keeper ring in position without causing damage to the EPDM seal.

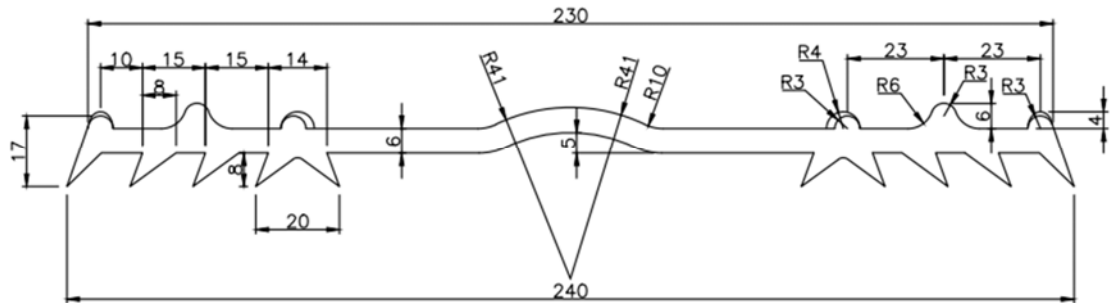


Figure 1 EPDM SEAL DRAWING

## 10. Special conditions

The Safety Particular Specification included in this document shall be adhered to in all respects.

It is a requirement of this Contract that the Contractor shall provide a safe and healthy working environment and to direct all his/her activities in such a manner that his/her employees and any other persons, who may be directly affected by his/her activities, are not exposed to hazards to their health and safety. To this end the Contractor shall assume full responsibility to conform to all the provisions of the Occupational Health and Safety Act No 85 and Amendment Act No 181 of 1993, and the OHS Act 1993 Construction Regulations 2003 issued on 18 July 2003 by the Department of Labour.
