The current IT infrastructure has already been virtualised and consists of 14 virtual servers (11 on production) all running versions of Microsoft Windows Server as the base operating system. These virtual servers run on 2 x Hyper V hosts. The proposals must satisfy the specified requirements as outlined below.

- b) Provide backup and recovery software with licences for the duration of the contract.
