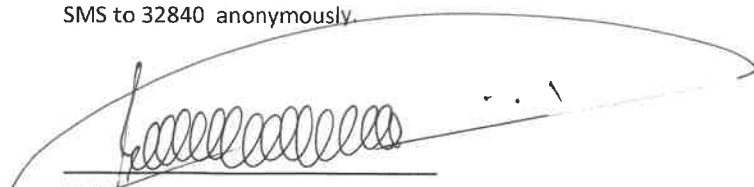

### **C3: Scope of Work**

#### **C3.1 Contract Information**

##### **1. Project Name**

Framework Contract for Maintenance and Upgrading of the Electrical Distribution Network.

##### **2. Project Description**

Appointment of a panel of (3) Three Electrical Contractors for the Maintenance and Upgrading of the Electrical Distribution Network.

The Elundini Local Municipality intends to appoint a suitably qualified and experienced panel of three **6EP and above** electrical contractors to perform maintenance, repairs, emergency response, and upgrade works on the municipal electrical distribution network on an as-and-when-required basis. The appointment is intended to supplement the capacity of the Municipality's Electricity Section whenever it does not have adequate human resources, specialised skills, plant, tools, or equipment to execute the required work.

##### **3. Project Background**

Elundini Local Municipality is responsible for providing a safe, reliable, and sustainable electricity supply to communities within its area of jurisdiction. To achieve this, the Municipality must continuously maintain, repair, and upgrade its electrical distribution network to ensure that infrastructure remains in good working condition and is able to meet the growing demand for electricity.

The Municipality's Electricity Section carries out routine maintenance, fault repairs, and network upgrades using its internal workforce. However, there are times when the available personnel, specialised skills, equipment, or plant are insufficient to complete the required work within the required timeframes. This is particularly the case during major faults, emergency situations, planned network upgrades, or when several projects need to be undertaken simultaneously.

To ensure that electricity services are not disrupted, and that maintenance and upgrade works are completed efficiently, the Municipality intends to appoint a suitably qualified and experienced electrical contractors to supplement its internal capacity on an as-and-when-required basis. The appointed contractors will work under the direction of the Municipality and will undertake maintenance, repairs, emergency response, and network upgrade works in accordance with applicable legislation, industry standards, and municipal specifications.

The appointment of a contractors will enable the Municipality to respond more effectively to electrical faults, improve the condition and reliability of the distribution network, reduce service interruptions, and ensure that critical maintenance and infrastructure upgrade projects are completed within reasonable timeframes. Ultimately, this contract will support the Municipality in delivering a reliable electricity service and improving the quality of service provided to residents, businesses, and other electricity consumers throughout the Elundini Local Municipality.

##### **2.1 Vision**

To have a panel of three (3) service providers for a period of 3 years without a quantum of works, this will provide efficient turnaround time in maintenance and upgrading of the Electrical Distribution Network.

##### **2.2 Mission**

- To actively respond to maintenance and upgrading of the Electrical Distribution Network.
- To quickly respond and implement the maintenance and upgrading of the Electrical Distribution Network.

- To promote broad based black economic empowerment.
- To promote local employment (temporary and permanent) through the delivery of the works.
- To retain as much of the project expenditure within the Elundini Local Municipality; and

### 2.3 Objectives

- The Employer's primary objective in entering into this framework contracts over a 3 year framework term for maintenance and upgrading of the Electrical Distribution Network relating to the development of Municipal Infrastructure Projects within the Elundini Municipal area of jurisdiction, on an as and when instructed basis without a commitment to a quantum of work, is to secure the services of a limited number of suitably qualified Service Providers to serve the Employer's current and emerging needs.
- The secondary or developmental objectives of the Employer are to provide employment and business opportunities to persons residing or located within the Elundini Municipal area.

### 2.4 Specific

- The Service Provider is required to provide all required personnel, equipment and tools required for Professional Services relating to the development of Municipal Infrastructure Projects and associated works as instructed through a Package Order within the Elundini Local Municipality
- Each Package Order will specify its own Works Information with the necessary details applicable for the project of that Work Package. This will include but not be limited to planning, design, monitoring, reporting, invoicing, technical details, drawings, location, Site Information as well as people employment requirements.

## 4. Scope of work/ deliverables

The appointed Contractors shall provide maintenance, repair, emergency response, and network upgrade services for the Elundini Local Municipality's electrical distribution network on an as-and-when-required basis. The Contractors will supplement the Municipality's internal capacity by providing the necessary skilled personnel, supervision, plant, equipment, tools, transport, and materials to carry out the required works.

The scope of work includes the maintenance and upgrading of the Municipality's 22 kV and 11 kV medium-voltage (MV) overhead and underground networks, as well as the low-voltage (LV) overhead and underground reticulation system. Works may be undertaken on transformers, mini-substations, switchgear, overhead lines, underground cables, service connections, street lighting infrastructure, and associated electrical equipment.

The Contractors will be required to perform planned and corrective maintenance, fault finding, emergency repairs, replacement of damaged or ageing infrastructure, installation of new electrical infrastructure, network strengthening, cable jointing and terminations, testing, commissioning, and restoration of electricity supply. The Contractor may also be required to undertake switching operations, vegetation clearing within electrical servitudes, excavation and reinstatement for underground cable works, and any other related electrical works as instructed by the Municipality.

Emergency call-out services shall be available on a 24-hour basis when required to ensure the prompt restoration of electricity supply following equipment failures, storms, accidents, or other unforeseen events.

All work shall be carried out in accordance with the Occupational Health and Safety Act, applicable SANS and NRS standards, municipal specifications, and recognised industry best practices. The Contractors shall ensure that all work is completed safely, efficiently, and to the satisfaction of the Municipality while minimising disruption to electricity consumers.
