## **1. Background**

## **2. Request for Quotation (RFQ)**

This RFQ serves as an invitation to submit a quotation for **supply, install and commission various humidifiers**, subject to the SABS Standard Terms and Conditions, of which a copy is available on [www.sabs.co.za](http://www.sabs.co.za), accessible through the link: [https://www.sabs.co.za/Procurement/proc\\_toc.asp](https://www.sabs.co.za/Procurement/proc_toc.asp)

The Bidder is requested to supply its quotation, in writing, by the date specified. Should the Bidder require any clarification, the clarification should be submitted by e-mail to the Procurement Specialist identified in this document.

By submitting a quotation in response to this RFQ or participating in this RFQ process, the Bidder accepts that it is subject to and bound by all the terms and conditions contained in this RFQ document.

## **3. Confidentiality**

This document may not be used for any purpose by the Bidder other than for developing their response to it, and all reasonable efforts must be taken by the Bidder to ensure confidentiality of any information provided. This document and any other information of a confidential nature provided to the Bidder during RFQ process are and will be covered by the non-disclosure agreement to be signed between the SABS and the Bidder.

## **4. No Contract**

Bidders shall note that this RFQ does not commit the SABS to any course of action resulting from the receipt of quotations and the SABS may, at its discretion reject any submission which does not conform to instructions and specifications which are contained herein or select a Bidder based upon its own unique set of criteria. The SABS also reserves the right not to select a bidder.

Nothing in this document shall be construed as a contract between the SABS and the Bidder, and no communication, whether verbal or written, by the SABS personnel or agents during the course of this process shall create such a contract in respect of the requirements specified in this RFQ.

## **5. No Obligation to Proceed**

The SABS reserves the right to discontinue the RFQ evaluation process at any time and will not be responsible for any losses incurred by the Bidder as a result of discontinuance of the RFQ process

## 6. Validity of Proposals

The Bidder's quotation shall remain valid for a period of one hundred and twenty (120) days from the closing date. The SABS may at any time prior to the expiry of the bid validity period, extend the above validity period by sixty (60) days by written notice to the Bidders. In that event, the SABS will not require any consent from the Bidders, and bidders will not be required or permitted to amend any of their quotations.

The SABS retains the right, but is under no obligation, to request Bidders to extend the validity periods of their quotations, prior to expiry thereof, if it has already invoked the extension referred to above and it is in the SABS' interest to further extend the bid validity period. Such request shall be in writing. The Bidder is not obliged to extend the validity period. Also, bidders will not be required or permitted to amend any of their quotations.

- Units must be able to operate on potable water and RO water

#### PART 2 - PRODUCTS

2.1 Provide Condair RS resistive element humidifier generating mineral-free, sterile steam for use with potable, De-Ionized (DI), or Reverse Osmosis (RO) water. Packaged unit, wall mounted, atmospheric steam generation using resistive heating element. Electrode technology and boiler steam (pressure steam) technology not acceptable.

#### 2.2 Unit[s] to be complete with:

- Touchscreen controller with standard building automation and Online connectivity.
- Intuitive touchscreen control with colour graphic user interface.
- Standard building automation communication protocols BACnet IP, BACnet MSTP and Modbus. Additional hardware required for building automation communication not acceptable.
- Embedded web interface for easy configuration and remote monitoring from any computer with a web browser over a local area network (LAN) connection.
- USB interface for new software/feature upload and download of operational information.
- Single or dual channel analog signal acceptance, supporting both demand and transducer control. Ability to control setpoint from humidifier control when using transducer controls.

#### Packaged system with Condair resistive element technology:

- Incoloy based resistive heating element for steam production.
- Modulating output between 4% and 100% of rated capacity.
- Control accuracy of up to +/- 1% RH using optional Precision solid state relay control and high precision humidistat.
- Separate scale collection chamber external from main boiling tank when using optional Scale Management system.
- Dual magnetic electronic float system located outside of the boiling water to ensure accurate water level control and reduced maintenance. Systems using conductivity probes or floats located within hot reservoir are not acceptable.
- Self-diagnostics during start-up of system to prevent unsafe operation of the unit[s]:
  - a. Fill valve check.
  - b. Float level check.
  - c. Drain pump check.
- Durable powder coated steel cabinet with zero side clearance requirement for minimal footprint.
- Insulating air gap between plumbing and electrical compartment for increased electronic reliability.
- Standard internal drain water tempering to ensure maximum 140°F [60°C] drain water. External drain water cooler not acceptable.
- Integral fill cup with minimum 1-inch [25 mm] air gap to prevent back siphoning.
- Automatic off-season shutdown [after 3 days of "no call"] will completely drain the boiling tank[s] and automatically restart on call for humidity.
- Programmable drain settings to allow cycling small water quantities during operation without interrupting steam production.
- Integral design allowing easy installation and access for servicing.

#### 2.3 Optional Accessories

- Steam lance and piping for allowing steam to be released into ducts. See BOQ.
