TERMS OF REFERENCE FOR THE RE-INSTATEMENT OF THE OLD SADPMR BUILDING TO ITS ORIGINAL STATE.

1. INTRODUCTION

1.1 The SADPMR wishes to appoint the service provider to re-instate the Ithemba Property building at 251 Fox/Berea Johannesburg.

2. OBJECTIVES AND SCOPE

- 3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:
